### Supporting Statement Application for Identification Card 1651-0008

#### Justification

CBP Form 3078, *Application for Identification Card*, is filled out in order to obtain an Identification Card which is used to gain access to CBP security areas. This form collects biographical information and is usually completed by licensed Cartmen or Lightermen whose duties require receiving, transporting, or otherwise handling imported merchandise which has not been released from CBP custody. This form is submitted to the local CBP office at the port of entry that the respondent will be requesting access to the Federal Inspection Section (FIS). Form 3078 is authorized by 19 U.S.C. 66, 1551, 1555, 1565, 1624, 1641; and 19 CFR 112.42, 118, 122.182, and 146.6. This information is needed to determine the eligibility of an employee seeking entrance to a CBP FIS area. CBP uses the information collected on Form 3078 to conduct a background investigation and thereby determine whether the applicant meets the criteria's required for the issuance of a CBP Hologram Identification card.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. CBP Form 3078 is a fillable form on CBP's website at: http://www.cbp.gov/sites/default/files/documents/CBP%20Form%203078.pdf. 19 CFR 112.42 requires that this form be submitted personally to the Port Director by the applicant, so electronic submission of this form would not be practical. CBP also requires a signed copy to certify that the information on the application is true and complete.

This information is not duplicated in any other place or any other form.

#### **12.** Provide estimates of the hour burden of the collection of information.

#### Public Cost

The estimated cost to the respondents is \$1,275,198. This is based on the estimated burden hours (42,450) multiplied by (x) the average loaded hourly wage rate for importers (\$30.04). CBP calculated this loaded wage rate by first multiplying the Bureau of Labor Statistics' (BLS) 2016 median hourly wage rate for Cargo and Freight Agents (\$20.15), which CBP assumes best represents the wage for importers, by the ratio of BLS' average 2016 total compensation to wages and salaries for Office and Administrative Support occupations (1.4762), the assumed occupational group for importers, to account for non-salary employee benefits.<sup>1,2</sup>

CBP then adjusted this figure, which was in 2015 U.S. dollars, to 2017 U.S. dollars by applying a 1.0 percent annual growth rate to the figure, as recommended by the U.S. Department of Transportation's value of travel time guidance.<sup>3</sup>

## 13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

# 14. Provide estimates of annualized cost to the Federal Government. Also provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information.

The estimated annual cost to the Federal Government associated with the review of these records is \$9,064,500. This is based on the number of responses that must be reviewed (150,000) multiplied by (x) the time burden to review and process each response (1 hour) = 150,000 hours multiplied by (x) the average hourly loaded rate for other CBP employees (\$60.43)<sup>4</sup> = \$9,064,500.

# 15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13 of this Statement.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There is no change to the information collected or to CBP Form 3078.

# 16. For collection of information whose results will be published, outline plans for tabulation, and publication.

This information collection will not be published for statistical purposes.
