PURPOSE:

FEMA OEA requests OMB approval to collect information related to stakeholders’ needs and preferences related to emergency management. FEMA OEA will collect customer satisfaction information from stakeholders from organizations serving individuals with limited English proficiency via a 10-minute survey (conducted via paper and entered into an online database). This collection of information is necessary to increase the effectiveness of preparedness and response information disseminated to stakeholders. This data collection will enable FEMA OEA to improve upon their strategies for reaching, educating, and communicating with stakeholders to ultimately improve emergency preparedness and response among the public.
