The survey results are used to measure program performance. As such, and due to the qualitative nature of participant's feedback collected from this survey, results are used in combination with other program metrics to document performance of EMI training program in compliance with Government Performance and Results Act (GPRA) and accountability reporting requirements. To date, evaluation data has been published in internal reports distributed to staff, been included in GPRA and accountability reports, and has caused management to closely review and modify courses based on survey results dating to 1997 and stored in the TIAS database. This form is administered by mail and is transitioning to web based.


