## Supporting Statement for Department of Veterans Affairs Acquisition Regulation (VAAR) 832.202-4, Security for Government Financing Approved OMB Control No. 2900-0688

## A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

This Paperwork Reduction Act (PRA) submission requests the reinstatement without change of Office of Management and Budget (OMB) approval No. 2900-0688, Department of Veterans Affairs Acquisition Regulation (VAAR) 832.202-4, Security for Government Financing.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

The information that is gathered under 832.202-4 will be used by the VA contracting officer to assess whether or not the contractor's overall financial condition represents adequate security to warrant paying the contractor in advance. FAR subpart 32.2 authorizes the use of certain types of Government financing on commercial item purchases. 41 United States Code (U.S.C.) 255(f) requires the Government to obtain adequate security for Government financing. However, FAR 32.202-4(a)(2) provides that, subject to agency regulations, the contracting officer may determine that an offeror's financial condition is adequate security. VAAR 832.202-4 Security for Government Financing specifies the type of information that the contracting officer may obtain to determine whether or not the offeror's financial condition constitutes adequate security.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

The collection of information will not involve automated, electronic, mechanical, or other technological collection techniques. However, contractors may elect to submit data via e-mail.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

There are no duplicated efforts. The information collected is specific to the given situation.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

There will be only minimal impact on any business, whether small or large. The amount of data submitted is at the discretion of the contractor. The contractor can chose to submit no data.

6. Describe the consequences to Federal program or policy activities if the collection is not conducted or is conducted less frequently as well as any technical or legal obstacles to reducing burden.

The consequences of not collecting the data required under VAAR 832.202-4 may be that a contractor would not qualify for advance payment under a contract and might thereby experience difficulty completing the contract.

- e. This is not a statistical survey.
- f. This does not require the use of statistical data classification.
- g. This does not include a pledge of confidentiality.
- h. This does not require the submission of proprietary information.
- 8. a. Notices regarding use of these clauses in all applicable solicitations were published in the <u>Federal Register</u> on January 10, 2018 (83 FR 1286) and on April 10, 2018 (83 FR 15454). VA did not receive any comments.

The request for information does not include any questions of a sensitive nature.

The information is evaluated upon receipt and a decision is made based on the data.
