Part A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

The Animal Health Protection Act of 2002 (7, U.S.C. 8301, et seq.), authorizes the Secretary of the U.S. Department of Agriculture (USDA) to prevent, control, and eliminate domestic animal diseases and take actions to prevent and manage foreign animal diseases. The Veterinary Services (VS) program of the Animal and Plant Health Inspection Service (APHIS), USDA, carries out this work. The National Import Export Services (NIES) unit of VS manages foreign animal diseases through controls and restrictions on imports and exports of animals and animal products.

To measure its success in carrying out this mission, NIES has instituted a customer service survey. The NIES survey gathers information from customers such as to individuals importing and exporting pet animals, importers and exporters of live animals for other uses, users of quarantine facilities, animal product and byproducts importers and exporters, and accredited veterinarians. The survey provides a general view of the public's perception of NIES customer service at VS Service Centers, Animal Import Centers, and air and seaports and indicates problems which can be addressed locally. The survey also provides feedback from customers on recommendations to improve customer service and allows customers to ask questions about VS.

APHIS is asking the Office of Management and Budget (OMB) to renew its use of this information collection activity for another 3 years.

2. Indicate how, by whom, how frequently, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

APHIS uses the following information activities to gather feedback from members of the public. The activities are designed to collect information pertaining to individuals importing and exporting pet animals, importers and exporters of live animals for other uses, users of quarantine facilities, animal product and byproducts importers and exporters, and accredited veterinarians.

VS 1-10/VS 1-10S (Spanish), Customer Service Survey – 9 CFR 1-199

VS 1-10/VS 1-10S, Customer Service Survey, is presented to the participant by an APHIS veterinary medical officer, document examiner, or animal health technician. The form can be returned to the Service Centers, air or sea ports, or the Animal Import Centers in person, by mail, or online through

SurveyMonkey. Contributing information is voluntary and anonymous. The form consists of seven multiple choice questions and four open-ended questions, with an opening question about:

- A. The type of capacity that the contact with VS was made, for example, Pet Animal Import/Export, Farm Animal Programs, Product Import/Export, Accredited Veterinarian, and Other (specify).
- B. Customer satisfaction level with VS regarding the following:
 - 1. Courtesy
 - 2. Professionalism
 - 3. Helpfulness
 - 4. Timeliness
 - 5. Knowledge
 - 6. Communication
 - 7. Treating you as a valued customer

Customers rate the numbered criteria above, as well as Question C below, using the scale of Very Satisfied, Somewhat Satisfied, Neither Satisfied nor Dissatisfied, Somewhat Dissatisfied, or Dissatisfied.

- C. How satisfied overall were you with your experience in our office?
- D. What was good about our service?
- E. What could we do better?
- F. Do you have a question about VS?

APHIS carries out the customer survey a minimum of once every 2 years. Sampling will be limited to a time period determined by each office which uses the survey, not to exceed 3 months. APHIS uses the information collected to improve customer service.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. The NIES surveys are available electronically through SurveyMonkey (<http://www.surveymonkey.com/r/VSSurvey2016>) as well as on paper.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purpose described in item 2 above.

The information that APHIS collects is not available from any other source. APHIS is the only Federal Agency responsible for preventing foreign animal diseases from entering the United States and certifying animals and animal products for export.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

APHIS estimates 80 percent of the respondents to this information collection are considered small entities. The information from these customers is helpful in the success of other data collection activities. The burden of this survey is minimized by keeping it short and voluntary.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

If the information were collected less frequently or not collected at all, it would hamper APHIS' ability to serve the public and, to a larger extent, affect how well it carries out its role in safeguarding animal and human health in the United States.

- **requiring respondents to report information to the agency more often than quarterly;**

On Thursday, December 22, 2016, pages 93883-93884, APHIS published in the Federal Register, a 60-day notice seeking public comments on its plans to request a 3-year renewal of this collection of information. One comments was received from the public in which they agree with continuation of the Veterinary Services National Import Export Services Customer Service Survey Project.

9. Explain any decision to provide any payment or gift to respondents, other than reenumeration of contractors or grantees.

No gifts or payments are proved to respondents; however, APHIS does provide postage paid return envelopes upon request for ease in replying.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

The survey is treated anonymously; individuals leave their personal information at their discretion. No additional assurance of confidentiality is provided with this information collection. Any and all information obtained in this collection shall not be disclosed except in accordance with 5 U.S.C. 552a.

This information collection activity will ask no questions of a personal or sensitive nature.

See APHIS Form 71. Burden estimates were developed from discussions with animal and product importers and exporters, farm owners, pet owners, organism and vector registered entities, and veterinarians.

APHIS estimates the total annualized cost to these respondents to be \$28,424. APHIS arrived at this figure by multiplying the total burden hours (760 hours) by the estimated average hourly wage of the above respondents (\$37.04). The hourly rate was derived from the U.S. Department of Labor, Bureau of Labor Statistics May 2015 Report – Occupational Employment and Wages in the United States. Importers/exporters: \$21.47 (animal breeders)

Farm owners: \$35.47 (Farmers, ranchers, and other agricultural managers)

Veterinarians: \$47.59

Laboratory technicians: \$23.22 (biological technicians)

Production facility managers: \$57.44 (general and operations managers)

There are no total capital and startup cost components.

The annualized cost to the Federal Government is estimated at \$51,867.35 (See APHIS Form 79).

There is a program increase of +15,000 respondents and +14,851 responses resulting in an increase of +512 total burden hours. The changes made during this renewal includes increasing the number of locations soliciting responses from approximately 6-8 to approximately 27, to account for all VS Animal Import Centers and air and sea ports. However, APHIS reduced the anticipated response rate from 50 percent to 33 percent to better reflect actual returns.

APHIS has no plans to publish information it collects in connection with this program.
