- 3. The issued Import Request, Form LPS-222 will be returned by mail. Alternate arrangements to return the Import Request can be established. The issued Import Request must be presented to U.S. Customs and Border Protection officials for conditional release pending inspection.
- 4. The importer or agent responsible for the shipment must provide LPS, USDA, with a contact at the shipment destination location. An LPS representative will schedule an inspection of the product and applicable import documents.

USDA

- 1. Upon arrival, complete inspection of the product and import documents.
- 2. Measure the ambient transport temperature inside the conveyance unit.
- 3. Record results in Section E.
- 4. When the Import Request submitted is acceptable, enter in the shell egg import permit number issued (located at the top right-hand corner of the form).
- 5. For a shipment accepted, sign, date and return form to importer's/consignor's agent.
- 6. If the shipment is refused entry, document the cause and disposition in the bottom portion of Section E. Submit the completed form to the LPS office listed to the left and notify the U.S. Customs and Border Protection official(s) at the point of entry.
