Title: Boundary and Annexation Survey (BAS) State Certification, State Certifying Official and Discrepancy Correspondence and Respondent Materials

Request: The U.S. Census Bureau (Census Bureau) requests to change the distribution and accessibility of the Boundary and Annexation Survey (BAS) State Certification respondent materials and correspondence from physical to electronic mail (email) delivery with downloadable files accessible through the BAS website. This includes the State Certifying Official (SCO) Letter (BASSC-4L), BAS State Certification Listings, and Discrepancy Letters (BASSC-1L and BASSC-2L), as referenced in the Background section of this document.

Background: The BAS State Certification program invites Governor-appointed SCOs from 49 of the 50 states (Hawaii is not included¹) to review legal boundary changes submitted to the annual BAS. The Census Bureau's Master Address File/Topologically Integrated Geographic Encoding and Referencing (MAF/TIGER) System and Geographic Change Catalog System (GCAT) capture these updates each year. The MAF/TIGER System houses all of the Census Bureau's spatial, geographic, and residential address data needed for census and survey data collection and tabulation. The BAS State Certification Program serves as a component to ensuring that the MAF/TIGER System and GCAT are accurate and complete.

The BAS SCO letter (BASSC-4L), delivered as part of the SCO respondent materials package, announces the start of the program and initiates the SCO's review of the BAS State Certification materials. In this package, the Census Bureau provides the SCO with a Compact Disc (CD) containing a respondent guide, Read Me file, and one to four Excel spreadsheets. The Excel spreadsheets, referred to as "listings," display the legal boundary changes, name changes, and government functional status changes from the previous BAS cycle added to the MAF/TIGER System and GCAT. The SCO reviews the legal boundary changes to ensure their submittal is in accordance with state law. Further, the SCO certifies changes as correct, or requests their removal from the Census Bureau's MAF/TIGER system and GCAT if not in accordance with state law. In addition, the Census Bureau invites the SCO to add legal boundary changes not reported during the previous BAS cycle.

Once the SCO submits their additions and/or removals to the Census Bureau, the Census Bureau informs the BAS contacts of local governments that had records marked for addition or removal by distributing Discrepancy Letters (BASSC-1L/BASSC-2L) to the affected entities.

Currently, the Census Bureau sends the BAS SCO letter (BASSC-4L) and respondent materials, including the CD containing the listings for review, to the SCO by physical mail delivery. The Census Bureau intends to make the listings and respondent materials available electronically for download on the BAS website, beginning in November 2017. The Census Bureau also intends to distribute the SCO letter, which will include instructions and the website address to access the listings, by email in November 2017. The Census Bureau intends to provide the SCO letter (BASSC-4L) as a PDF attachment to a generic

email body. The Census Bureau also distributes the Discrepancy Letters (BASSC-1L/BASSC-2L) by physical mail delivery at this time and plans to deliver the Discrepancy Letters in February 2018 for the 2017 BAS State Certification cycle. The Census Bureau intends to begin distributing this notification by email in February 2018. The Census Bureau intends to provide the Discrepancy Letters (BASSC-1L/BASSC-2L) as a PDF attachment to a generic email body.

Timeline: The Census Bureau conducts the BAS State Certification Program annually.

- October 2017: Letter to Governor to appoint SCO (BASSC-3L) distributed by physical mail.
- November 2017: Distribution of the SCO letter (BASSC-4L) for the next program cycle by email.
- November 2017: BAS State Certification Listings available for download on the BAS State Certification webpage.
- February 2018: 2017 BAS State Certification Discrepancy Letters (BASSC-1L/BASSC-2L) will be distributed by email.

Method: Currently, the BAS State Certification Program outreach consists of four separate mailings.

- October: A letter to the Governor to appoint an SCO (BASSC-3L) will remain as a physical mail delivery.
- November: A respondent package to the SCO containing the SCO letter (BASSC-4L) and the BAS State Certification respondent materials which include the *BAS State Certification Respondent Guide* and the BAS State Certification listings.
- February (2018): A letter to the government where a legal boundary change was marked for removal by the SCO (BASSC-1L).
- February (2018): A letter to the government where a legal boundary change was added by the SCO (BASSC-2L).

With the first mailing, the Census Bureau requests each Governor to appoint an SCO for their state. The Census Bureau will continue to send this letter by physical mail delivery.

The second mailing notifies the SCO of their appointment by the Governor and provides the SCO with the respondent materials, including the *BAS State Certification Respondent Guide* and listings for review to complete the BAS State Certification. This correspondence will be distributed by email beginning in November 2017. Respondent materials, including the listings, will be accessible for download through the BAS State Certification webpage, which is located on the BAS website.

The third and fourth mailings are sent at the same time to the affected local government BAS contacts. The BASSC-1L letter informs the BAS contact that a legal boundary change was not reported in accordance to their state's law and to resolve these discrepancies with their SCO. The BASSC-2L letter informs the BAS contact that they did not submit changes to the BAS and requests that they do so in the following BAS cycle. These letters will be distributed by email in February 2018.

A majority of the BAS materials are delivered by email and are available for download from the BAS website, therefore the BAS and SCO contacts are experienced with BAS email correspondence.

All SCOs currently have active email addresses and access to the internet. If delivery to an email address fails, the Census Bureau will work directly with the SCO or BAS contact to revise the contact information and email address on file. In the case that the email failure cannot be resolved, the Census Bureau will distribute the physical letter to that individual SCO or BAS contact by FedEx or USPS. In the case that an

SCO or BAS contact does not have an email address or access to the internet, the Census Bureau will distribute the physical letter to that individual SCO by FedEx or USPS.

Use Incentives: None.

Burden: There is no change in burden of hours with the BAS and BAS State Certification programs. There is no additional request for information. Further, the frequency in which governments are contacted is unchanged.

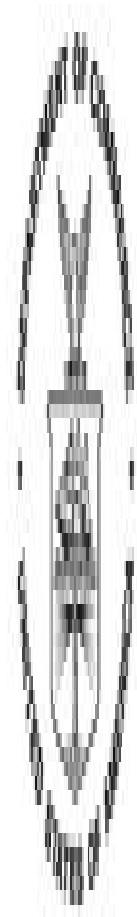

The U.S. Census Bureau (Census Bureau) conducts the Boundary and Annexation Survey (BAS) State Certification Program following the completion of the annual BAS. Through the BAS State Certification, the Census Bureau provides legal boundary and name changes reported to the BAS to the governor-appointed State Certifying Official (SCO). The SCO verifies that all approved changes were reported and in accordance with state law. The BAS State Certification ensures the accuracy of geographic boundaries used to tabulate data for the decennial and economic censuses, and for annual estimates and surveys such as the American Community Survey and Population Estimates Program.

During the 2016 BAS State Certification, the SCO reviewed 2013, 2015, and 2016 BAS changes. The 2014 BAS was cancelled. The SCO notified the Census Bureau that one or more boundary changes, which are listed in the attached form, were not implemented in accordance with state law. If you believe these boundary changes are legally in effect, ensure the required documentation is filed with the appropriate state or county level agency. Please contact your SCO, listed at the bottom of this letter to resolve the boundary changes in question. Once resolved, resubmit the boundary changes with appropriate documentation to the Census Bureau via e-mail at geo.bas@census.gov by September 15, 2017.

During the BAS State Certification process, the Census Bureau provides the information regarding legal boundary and name changes that were reported to the previous BAS to the governor-appointed State Certifying Official (SCO) for review and verification that all changes were submitted and that they were reported in accordance with state law. The BAS State Certification Program helps to ensure the quality and accuracy of the geographic boundaries that are used to represent and report census and survey data.

During the 2016 BAS State Certification, which took place in April 2017, the SCO reviewed changes that were submitted during the 2013, 2015, and 2016 BAS years. The 2014 BAS was cancelled. The SCO notified the Census Bureau that one or more boundary changes for your government were not reported to the BAS. Please see the enclosed form which lists the boundary changes that the SCO indicated were not reported to the BAS. To ensure these boundary changes get included in the Census Bureau's database, please submit any of these boundary changes that are legally in effect to the next annual BAS cycle which will occur in January 2018.

Notify your State Certifying Official, listed at the bottom of this letter, if any of the boundary changes listed were cancelled or not implemented.
