<u>Hard Freeze Watch</u>: Conditions are favorable for a freeze event to meet or exceed Hard Freeze Warning criteria in the next 12 to 48 hours during the locally defined growing season.

<u>Hard Freeze Warning</u>: Minimum shelter temperature is forecast to be 28°F or less (slightly lower or higher based on local criteria) during the locally defined growing season.

- * ADDITIONAL DETAILS...Ensure pets have warm shelter and unfrozen water. If you have not already done so, drain water from irrigation and swamp cooler lines.
