

## Department of the Interior Museum Catalog Records Data Standards<sup>1</sup>

In an effort to increase accountability and improve the management of and public access to its museum collections, the Department of the Interior (DOI) uses the set of data standards provided below to catalog its museum objects housed at both bureau facilities and non-Federal repositories. Additionally, the DOI is working towards consolidating documentation by migrating catalog data to the Interior Collection Management System (ICMS).

DOI recognizes that non-Federal repositories may not have the information to complete all the fields below for each object. DOI asks that non-Federal repositories voluntarily provide the data for as many fields as possible per object in an Excel spreadsheet or similar format. This will enable DOI to migrate the data into ICMS.

- A. For **all museum collections**, please record the following mandatory catalog data.
- (1) *Accession number.*
  - (2) *Catalog number.*
  - (3) *Discipline type and classification.* The disciplines used to classify and report DOI museum property are archaeology, archives, art, biology, ethnography, geology, history, and paleontology.
  - (4) *Object or scientific name.*
  - (5) *Unit acronym and/or identifier.*
  - (6) *Controlled property status.*
  - (7) *Item count or quantity.* Report item count, lot, bulk, and/or linear feet (archives only) as applicable.
  - (8) *Current location.*
  - (9) *Description.* In addition to physical description, this field may be used to record the object's associations with people, resources, or events, and interpretive and research data.
  - (10) *Condition.*
  - (11) *Date cataloged.*
  - (12) *Cataloger.*

B. For **archaeology** objects, please record the following mandatory catalog data for site location and/or provenience in addition to the data in section A.

- (1) *State site number.*
- (2) *Field site number (as available).*
- (3) *Site name and/or place name (as available).*
- (4) *Within-site provenience, including collection/excavation unit (as available).*
- (5) *UTM coordinates, latitude and longitude, or township/range/section (as available).*
- (6) *County.*
- (7) *State.*
- (8) *Country (if other than the United States).*

C. For **biology, geology, and paleontology** specimens, record the following mandatory catalog data in addition to the data in section A.

- (1) *Type specimen (if designated and appropriate to the discipline type).*
- (2) *Identifier(s).*
- (3) *Collecting locality (as available):*
  - a. *Collecting locality name and/or place name.*
  - b. *UTM coordinates, latitude and longitude, or township/range/section.*
  - c. *Collection unit.*
  - d. *County.*
  - e. *State.*
  - f. *Country (if other than the United States).*
  - g. *Formation (geology and paleontology only).*
  - h. *Period/system (geology and paleontology only).*
- (4) *Collector(s).*

- (5) *Collector's number.*
  - (6) *Collection date.*
  - (7) *Preservative and/or preparation.*
- D. For **archives**, record the following mandatory catalog data in addition to the data in section A.
- (1) *Local collection number.* This may be the same as the catalog number.
  - (2) *Collection title.*
  - (3) *Date(s) documents were created.*
  - (4) *Scope and content.* This may include but is not limited to information such as collection size and/or materials within the collection (e.g. negatives, documents)
  - (5) *History of the organization or person who created the record group.*
  - (6) *Organization and/or arrangement.*

**Paperwork Reduction Act Statement:** This information is collected on a voluntary basis to satisfy DOI's responsibilities for ensuring the proper management of DOI museum collections held at non-Federal repositories as defined in 36 CFR Part 79.
