**TITLE OF INFORMATION COLLECTION:** Department of State Passport Services Secure Live Photo Expanded Pilot Customer Survey

**PURPOSE:**

The Department of State Passport Services (PPT) is expanding its Secure Live Photo pilot, offering photo capture services to customers who apply for their passport at a Passport Agency (which has historically been done externally). Over the next 18 months, PPT is testing this new capability across the country to continually refine and improve the operations and workflow. PPT currently collects metrics internally but does not have a sense of public sentiment around the new photo capture offering. Through a basic customer satisfaction survey, PPT would like to pulse their customers to better understand how to improve Secure Live Photo in the future.

**DESCRIPTION OF RESPONDENTS:**

On a voluntary basis, respondents to the survey will include customers who apply for a U.S. passport at a designated Passport Agency and get their passport photo taken while they are there.
