An attorney or accredited representative appearing before DHS must file Form G-28 in each case. U.S. Citizenship and Immigration Services (USCIS), U.S. Customs and Border Protection (CBP), and U.S. Immigration and Customs Enforcement (ICE) will only recognize Form G-28 for the appearance of an attorney or accredited representative once the applicant, petitioner, requestor, or respondent has completed, signed, and filed a Form G-28.</p> <p><b>NOTE: Do not</b> file this form on a matter pending before the Board of Immigration Appeals (BIA); instead file Form EOIR-27, Notice of Entry of Appearance Before the Board of Immigration Appeals, to notify the BIA of your representation in matters</p>	<p>[Page 1]</p> <p><b>What Is the Purpose of Form G-28?</b></p> <p>This form is used to establish the eligibility of an attorney or accredited representative to represent a client (applicant, petitioner, requestor, beneficiary or derivative, or respondent) in an immigration matter before U.S. Department of Homeland Security (DHS). An attorney or accredited representative appearing before DHS must file Form G-28 in each case. U.S. Citizenship and Immigration Services (USCIS), U.S. Customs and Border Protection (CBP), and U.S. Immigration and Customs Enforcement (ICE) will only recognize a properly completed Form G-28 that was signed by the attorney or accredited representative and the client.</p> <p>USCIS, CBP, and ICE will recognize Form G-28 until the conclusion of the matter for which it is entered, unless otherwise notified. You must file a new Form G-28 with the Administrative Appeals Office if you are filing Form I-290B, Notice of Appeal or Motion.</p> <p><b>NOTE: For matters</b> before the Board of Immigration Appeals (BIA), use Form EOIR-27 instead of Form G-28.</p>
