SPECIFIC PTA QUESTIONS

1. Reason for submitting the PTA: Choose an item.

The information is used by contractors to obtain program benefits, consisting of distribution of insured mortgage proceeds when construction costs are involved. The information regarding completed work items is used by the Multifamily HUB Centers to ensure that payments from mortgage proceeds are made for work actually completed in a satisfactory manner. The work must be inspected and proved by a HUD Field Office Inspector and an architect not employed by HUD. To ensure compliance with prevailing wage rates, the Field Office uses the certification on form HUD-92448 regarding prevailing wages.

29CFR3.3 requires the contractor to submit an executed document certifying adherence to requirements of the Davis Bacon and Related Acts (DBRA) and the Copeland "Anti-Kickback" Act with regard to wages paid to employees. The contractor submits the completed form to HUD for review and determination of acceptability/unacceptability.

If the information was not collected, the Department would fail to meet the intent of the law and Federal regulations. The result in not collecting this information would lead to the failure of HUD to monitor the disbursement of mortgage proceeds and compliance with prevailing wage rates. If the collection of information was not conducted, disbursement of mortgage proceeds and compliance with prevailing wage rates could not be monitored. If the information was collected less frequently, the general contractor might have to borrow funds to meet expenses, thus increasing project development cost, and increasing the possibility of default and risk to the mortgage insurance fund.

³ Header: Information that is placed before the actual data. The header normally contains a small number of bytes of control information, which is used to communicate important facts about the data that the message contains and how it is to be interpreted and used. It serves as the communication and control link between protocol elements on different devices.

Payload data: The actual data to be transmitted, often called the payload of the message (metaphorically borrowing a term from the space industry!) 


