This is in response to your September 25, 2014 letter regarding the January 2015 supplementary payment levels. You requested Iowa's decision concerning Supplemental Security Income (SSI) cost-of-living adjustments for State Supplementary Assistance cases.

Iowa elects to pass along the full amount of the January 1, 2015, SSI cost-of-living adjustment to all State Supplementary Assistance cases for both mandatory and optional coverage groups.

Payment levels for each of Iowa's State Supplementary Assistance living arrangements, effective January 1, 2015, are attached. These new payment levels were calculated based on the reported 1.7% Social Security cost-of-living adjustment to be effective January 1, 2015.
