

**SUPPORTING STATEMENT FOR
Request for Hearing on a Decision
OMB Control No.: 1615-0050
COLLECTION INSTRUMENT(S): N-336**

A. Justification

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

Section 336 of the Immigration and Nationality Act (the Act) allows an applicant to request a hearing before an immigration officer if his or her application for naturalization was denied after an examination by U.S. Citizenship and Immigration Services (USCIS), under section 335 of the Act.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

This form provides a method for applicants, whose applications for naturalization are denied, to request a new hearing by an Immigration Officer of the same or higher rank as the denying officer, within 30 days of the original decision. This form is being revised. See attached table of changes.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

Form N-336 has two filing options for completion and submission.

The paper version: The form and instructions can be accessed as a fillable, printable PDF. It can be completed and saved electronically, but the form has to be printed and returned to USCIS via mail. It is available online at www.uscis.gov.

The electronic version: The electronic version of the form can both be completed and submitted electronically. The link will be activated upon the approval of the information collection instrument.

4. **Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

A search of USCIS forms inventory report revealed no duplication of effort and there is no other similar information currently available that can be used for this purpose.

This collection of information does not impact small businesses or other small entities.

6. Without Form N-336, an applicant would not be able to request a hearing before an immigration officer if his or her application for naturalization was denied after an examination by USCIS, under section 335 of the Act.

7. **Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- **Requiring respondents to report information to the agency more often than quarterly;**
- **Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **Requiring respondents to submit more than an original and two copies of any document;**
- **Requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
- **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
- **Requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**

- **That includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**
- **Requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

This information collection is conducted in a manner consistent with the guidelines in 5 CFR 1320.5(d)(2).

- 8. If applicable, provide a copy and identify the data and page number of publication in the Federal Register of the agency's notice, required by 5 CFR 1320.8(d), soliciting comments on the information collection prior to submission to OMB. Consultation with representatives of those from whom information is to be obtained or those who must compile records should occur at least once every 3 years - even if the collection of information activity is the same as in prior periods. There may be circumstances that may preclude consultation in a specific situation. These circumstances should be explained.

On July 13, 2015 USCIS published a 60-day notice in the Federal Register at 80 FR 40082. USCIS did receive comments after publishing that notice. Responses to the comments are in the separate Comment Matrix document.

On December 09, 2015, USCIS published a 30-day notice in the Federal Register at 80 FR 76564. USCIS did not receive comments.

- 9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.**

USCIS does not provide any payment for benefit sought.

- 10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation or agency policy.**

There is no assurance of confidentiality. The system of record notice associated with this information collection is the Alien File (A-File) and Central Index System (CIS), which was published in the Federal Register on November 21, 2013 at 78 FR 69864. The privacy impact assessment associated with this information collection is the Integrated Digitization Document Management Program (IDDMP).

- 11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private. There are no questions of a sensitive nature.

* The above Average Hourly Wage Rate is the May 2014 Bureau of Labor Statistics average wage for All Occupations of \$22.71 times the wage rate benefit multiplier of 1.4 (to account for benefits provided) equaling \$31.79. When “All Occupations” is selected, include the following language: “The selection of “All Occupations” was chosen as the expected respondents for this collection could be expected to be from any occupation.”

13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 and 14).

- **The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. The estimates should take into account costs associated with generating, maintaining, and disclosing or providing the information. Include descriptions of methods used to estimate major cost factors including system and technology acquisition, expected useful life of capital equipment, the discount rate(s), and the time period over which costs will be incurred. Respondents to this collection of information may incur costs associated with obtaining documents to support answers, translation services, retaining an attorney, postage, and other costs as necessary. USCIS estimates that an average cost of \$250.00 per respondent may be incurred times 5,253 respondents equals a total of \$1,313,250.

There is a fee of \$650 associated with this collection of information

Government Cost

The estimated cost of the program to the Government is calculated by multiplying the estimated number of respondents (5,523) x \$650 fee charge (which includes the suggested average hourly rate for clerical, officer, and supervisory time with benefits). This figure includes the estimated overhead cost for printing, stocking, and distributing the form.
