Crew Member's Declaration

Justification

CBP Form 5129, *Crew Member's Declaration*, is a declaration made by crew members listing all goods acquired abroad which are in his/her possession at the time of arrival in the United States. The data collected on CBP Form 5129 is used for compliance with currency reporting requirements, supplemental immigration documentation, agricultural quarantine matters, and the importation of merchandise by crew members who complete the individual declaration. This form is authorized by 19 USC 1431 and provided for by 19 CFR 4.7, 4.81, 122.83, 122.84, 148.61-148.67. The data submitted on CBP Form 5129 is used by CBP to determine applicable duty payments and/or compliance with all applicable laws.

This form is filled out on vessels and submitted at seaports; therefore, it would not be appropriate to submit it electronically.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

The information collected on CBP Form 5129 is necessary upon every arrival in the United States as part of the requirements to declare items acquired abroad or to be landed in the United States. Less frequent collection compromises revenue collection, agriculture quarantines, and compliance with other applicable laws.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on January 8, 2018 (Volume 83, Pages 827) on which no comments were received, and on May 25, 2018 (Volume 83, Pages 24326) on which no comments were received.

There is no offer of a monetary or material value for this information collection.

A PIA for the Advance Passenger Information System (APIS), dated June 5, 2015 and a SORN for APIS dated March 13, 2015 (80 FR 13407) will be included with this ICR. There are no assurances of confidentiality provided to the respondents of this information collection.

Public Cost

The estimated cost to the respondents is \$54,003,120. This is based on the estimated burden hours (996,000) multiplied by (x) the average loaded hourly wage rate for captains, mates, and pilots of water vessels (\$54.22). CBP calculated this loaded wage rate by first multiplying the Bureau of Labor Statistics' (BLS) 2016 median hourly wage rate for Captains, Mates, and Pilots of Water Vessels (\$34.94) by the ratio of BLS' average 2016 total compensation to wages and salaries for Transportation and Material Moving occupations (1.5363), the assumed occupational group for captains, mates, and pilots of water vessels, to account for non-salary employee benefits.^{1,2} CBP then adjusted this figure, which was in 2015 U.S. dollars, to 2017 U.S. dollars by applying a 1.0 percent annual growth rate to the figure, as recommended by the U.S. Department of Transportation's value of travel time guidance.³

² The total compensation to wages and salaries ratio is equal to the calculated average of the 2016 quarterly estimates (shown under Mar., June, Sep., Dec.) of the total compensation cost per hour worked for Transportation and Material Moving occupations (\$28.08) divided by the calculated average of the 2016 quarterly estimates (shown under Mar., June, Sep., Dec.) of wages and salaries cost per hour worked for the same occupation category (\$18.2775). There are no record keeping, capital, start-up, or maintenance costs associated with this information collection.

The estimated annual cost to the Federal Government associated with the review of these records is \$33,276,360. This is based on the number of responses that must be reviewed (6,000,000) multiplied by (x) the time burden to review and process each response (5 minutes or .083 hours) = 498,000 hours multiplied by (x) the average hourly loaded rate for a CBP Officer (\$66.82)⁴ = \$33,276,360.

15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection.

This information collection will not be published for statistical purposes.

CBP will display the expiration date for OMB approval of this information collection.
