

**SUPPORTING STATEMENT**  
**Immigrant Petition by Alien Entrepreneur**  
**OMB Control No.: 1615-0026**  
**COLLECTION INSTRUMENT: Form I-526**

**A. Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

Section 203(b)(5) of the Immigration Nationality Act, allows qualified immigrants seeking to enter the United States for the purpose of engaging in a commercial enterprise to receive an immigrant visa. To receive EB-5 status, applicants must file a Form I-526, Immigrant Petition by Alien Entrepreneur with U.S. Citizenship and Immigration Services, with the fees prescribed in 8 CFR 103.7(b), and in accordance with the form instructions.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The data collected on this form will be used by USCIS to determine the eligibility of qualified aliens to enter the United States to engage in commercial enterprises. USCIS's approval of the Form I-526 demonstrates that the alien entrepreneur is investing or has invested the required amount of capital in a qualifying commercial enterprise, some of which may be located within Regional Centers (RCs), Rural Areas (RAs) or Targeted Employment Areas (TEAs). The petition must include evidence that the aliens have made either a \$500,000 or \$1 million U.S. dollar investment of lawful capital in a new or existing commercial enterprise. The form serves the purpose of standardizing requests for the benefit, and ensuring that basic information required to determine eligibility is provided by applicants.

Form I-526 is being revised to incorporate additional information regarding the petitioner and to better establish how the petitioner meets the eligibility criteria for the EB-5 preference category. Specifically, the form will now capture biographic information regarding the petitioner, such as residential addresses and employment, necessary to better determine the lawful source of the petitioner's funds. Additionally, the form has been revised to collect data on the source of the petitioner's investment funds. Finally, other edits have been made to enhance operational efficiencies and reduce processing times. For example, more information regarding how the petitioner plans to meet the job

creation requirement (via the regional center program or not) is requested, along with details if the petitioner is investing in a new commercial enterprise associated with a regional center. Further, USCIS is implementing a new commercial enterprise (NCE) identification (NCE ID) number to better assist operations in ensuring cases associated with the same NCE are more timely and consistently adjudicated.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

The Form I-526 is currently available as an electronic form that can be accessed and completed online and then printed and mailed to the USCIS.

USCIS intends to make the Form I-526 available for filing through its internet-based account and adjudication system known as USCIS Electronic Immigration System (USCIS ELIS) in 2Q FY 2017. The screen shots and wizard decision tree for the collection of this information in USCIS ELIS is provided with this submission to OMB for approval and posted in the docket for public comments. In addition, the Petitioner will be presented with a list of evidence that should be filed with the submission of the petition. The petitioner will be able to upload their documents as one of five acceptable file types (.bmp, .doc, .jpg, .pdf, .tif). After uploading files, the petitioner will be able to view, delete, and add additional documents as necessary. The documents will not be submitted to USCIS until the applicant completes the e-sign, submission, and payment steps for the petition. The screen shots for the evidence requirements is provided with this submission to OMB for approval and posted in the docket for public comments.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

USCIS has investigated its internal processes, files and data as well as those of other Federal agencies that may service the same population. USCIS was not able to find any other means by which the information necessary for this process could be obtained except for the use of the form submitted for approval in this emergency request. USCIS will

continue to examine ways in which information may be obtained from other sources and any identified duplications can be minimized or removed.

**5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.**

The collection of information does not have an impact on small businesses or other small entities.

**6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.**

Without the use of this information collection, an alien may not apply and USCIS may not be able to determine an alien's eligibility for special immigrant status.

**7. Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- **Requiring respondents to report information to the agency more often than quarterly;**
- **Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **Requiring respondents to submit more than an original and two copies of any document;**
- **Requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
- **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
- **Requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**
- **That includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**
- **Requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

This information collection is conducted in a manner consistent with the guidelines in 5 CFR 1320.5(d)(2).

- 8. If applicable, provide a copy and identify the data and page number of publication in the Federal Register of the agency's notice, required by 5 CFR 1320.8(d), soliciting comments on the information collection prior to submission to OMB. Summarize public comments received in response to that notice and describe actions taken by the agency in response to these comments. **Consultation with representatives of those from whom information is to be obtained or those who must compile records should occur at least once every 3 years - even if the collection of information activity is the same as in prior periods. There may be circumstances that may preclude consultation in a specific situation. These circumstances should be explained.**

On May 4, 2018 USCIS published a 60-day notice in the Federal Register at 83 FR 19798. USCIS did receive comments after publishing that notice. The first commenter suggested minor formatting and language changes to the information collection. The second commenter suggested content changes to the information collection. USCIS appreciates these commenters' participation and suggestions. At this time, USCIS will not make changes to the information collection.

On August 15, 2018, USCIS published a 30-day notice in the Federal Register at 83 FR 40542. USCIS did not receive comments.

- 9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.**

USCIS does not provide payments or gifts to respondents related to this information collection.

- 10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation or agency policy.**

There is no assurance of confidentiality. The system of record notice associated with this information collection include:

- United States Citizenship and Immigration Services Benefits Information System, which was published in the Federal Register on October 19, 2016 at 81 FR 72069, and

- United States Citizenship and Immigration Services Alien File, Index, and National File Tracking System of Records, which was published on September 18, 2017 at 82 FR 43556.

The privacy impact assessment associated with this information collection include,

- DHS/USCIS/PIA-016(a) CLAIMS3 and Associated Systems PIA, which was published on March 25, 2016, and
- DHS/USCIS/PIA-003 Integrated Digitization Document Mianagement Program (IDDMP) PIA, which was published on January 5, 2007.

There are no questions of a sensitive nature.

*\*The above Average Hourly Wage Rate is the [May 2017 Bureau of Labor Statistics](#) average wage for All Occupations of \$24.34 times the wage rate benefit multiplier of 1.46 (to account for benefits provided) equaling \$35.54. The selection of "All Occupations" was chosen as the expected respondents for this collection could be expected to be from any occupation.*

**13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 and 14).**

- **The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. The estimates should take into account costs associated with generating, maintaining, and disclosing or providing the information. Include descriptions of methods used to estimate major cost factors including system and technology acquisition, expected useful life of capital equipment, the discount rate(s), and the time period over which costs will be incurred. For form preparation, legal services, translators, and document search and generation, USCIS estimates the average cost of this information collection may vary widely, from as little as \$200 to \$2,000 per respondent. Using the midpoint of the range of such expenses, USCIS estimates that respondents would face a cost of \$1,100 for these activities. All respondents for this collection may incur this cost. USCIS estimates the total estimated cost is number of respondents (11,460) times the average cost per respondent (\$1,100) totaling \$12,606,000.

There is a \$3,675 fee charge associated with this information collection.

- 14. Provide estimates of annualized cost to the Federal government. Also, provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment, overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information. **The Total Cost to Government is \$42,115,500.** The estimated cost of the program to USCIS, which is recovered by the collection of fees, is calculated by using the estimated number of respondents (11,460) multiplied by the fee (\$3,675), which includes the suggested average hourly rate for clerical, officer, and managerial time with benefits, plus a percent for the estimated overhead cost for stocking, distributing and processing of this form.

- 15. Explain the reasons for any program changes or adjustments reporting in Items 13 or 14 of the OMB Form 83-I.**

There was a decrease of 8,289 from the annual burden hours previously reported for this information collection. This change is due to a decrease in the number of respondents estimated to submit this form.

There was a decrease of \$526,900 from the annual cost burden previously reported for this information collection. This change is due to a decrease in the number of respondents estimated to submit this form.
