This survey is about your satisfaction with the YMYG training and materials that you received. You're eligible to be in this study because you attended a YMYG training on behalf of your organization. Please note that **we are not conducting this survey to evaluate you or your organization**. The focus of this survey is to understand how the CFPB can improve the training and develop new resources for organizations and individuals interested in using YMYG.

Your answers will help to inform the YMYG program and toolkit and will benefit those who are trained to use YMYG.

There are no foreseeable risks involved in participating in this survey other than those encountered in day-to-day life.

Your survey answers will be collected by our partner Davis Research and stored in a password protected electronic format. Your name and employer name will not be linked to your survey responses. Therefore, your responses will remain anonymous. Information about whether you participated will be kept separate from your responses. No one will be able to identify you or your answers. No names or identifying information about you or your organization will be included in any publications or presentations based on this data, and your responses to this survey will remain private.
