Preventing and Addressing Intimate Violence when Engaging Dads Interviews

Child Trends, an independent research organization, and their partners, Boston Medical Center and Futures Without Violence, are contracting with the Administration for Children and Families in the U.S. Department of Health and Human Services to conduct a research study to describe fatherhood programming that addresses violence that occurs between fathers and their current or former romantic partners. 1. PURPOSE:

We would like to ask you about your experiences providing services to fathers and families in fatherhood programs. Our goal is to better understand how fatherhood programs address IPV.

2. PROCEDURES:

If you agree, you will participate in an approximately 90-minute interview. During the interview, we will ask you about how your organization addresses IPV among fatherhood program participants. The topics covered in the interview include how you identify IPV, and programming and partnerships to prevent and address IPV.

3. RISKS AND/OR DISCOMFORTS:

Risks associated with participation include potential loss of privacy. To protect you or your organization's privacy, your name or your organization's name will not be used in reports without your permission and your individual responses will not be shown to anyone outside of the study team. Some questions may make you uncomfortable. If we come to a question you do not wish to answer, you can let the interviewer know and he/she will move on to the next question.

4. VOLUNTARY PARTICIPATION:

This collection of information is voluntary and will be used to better understand fatherhood programs. You can choose to stop the interview at any point. If after completing the interview you no longer wish to participate, the interviewer know or you can contact David Scott at 240-223-9324 to be removed from the study.
