- Thank you very much for your time. Let me start by telling you a little about what we will be doing today. The Commodity Flow Survey provides detailed data on the movement of goods in the United States, and the data are used to analyze trends, to forecast the demand of goods, and to determine the need for associated infrastructure and equipment.
- Today we'd like to get your feedback on whether you would be able to provide us with data relating to the shipment of hazardous material (HAZMAT) and what the level of burden associated with retrieving that data might be.

 - Are they descriptions unique to your company and not easily understood?
 - [If codes] Are these codes company specific?
- Could you show us your records that have this information in them?
- Considering these different variables we discussed (type, volume, mode of transport, location) if we asked you to provide more detailed data relating to HAZMAT on the Commodity Flow Survey, can you estimate what the additional burden of retrieving this would be?
