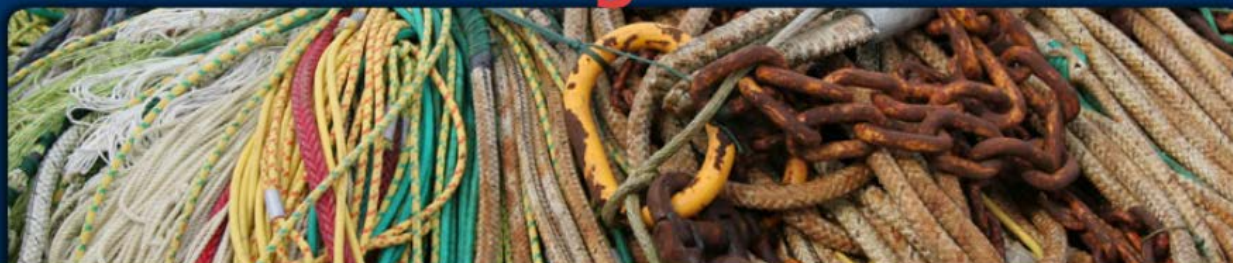

Pounds Purchased (round weight): Enter the total weight in unprocessed pounds of BSAI Pacific cod that was purchased and landed at the shoreside processor or mothership during the period January 1 through October 31. This includes target and non-target Pacific cod that was sold.

Total Ex-Vessel Value Paid: Enter the total gross ex-vessel value, in U.S. dollars and cents, of Pacific cod that was purchased and landed during the period January 1 through October 31.
