The screen capture images that follow show ALL of the questions included in the survey. Questions numbered with decimals (e.g., 1.1) are only displayed when the preceding response option is selected, triggering the display logic for the sub-question. For example, selecting the response option "Other, please specify." triggers display of a follow-up question and open-ended response text box.
