#### Part 4. Verification of Identity and Subject of Record Consent

If you request records about yourself (in other words, you are the Subject of Record), you are required to verify your identity by providing your full name, your current address, your date of birth, and your place of birth in Item Numbers 1.a. - 4. You must also sign this request, and you must either have your signature notarized or submitted under penalty of perjury, which you can do by completing either Item Number 8.a. or 8.b. in this section. If you request records about another individual (in other words, the other individual is the Subject of Record) and on behalf of that individual, you are still required to provide a statement from the individual verifying his or her identity, as well as certifying the individual's agreement that USCIS may release his or her records to you. Again, you can fulfill these requirements by completing Item Numbers 1.a. - 4. and then having the individual complete either Item Number 8.a. or 8.b.

# Part 4. Verification of Identity and Subject of Record Consent

If you are NOT the Subject of Record but are requesting records on behalf of that individual, you must still provide a statement from the individual verifying his or her identity and certifying the individual's agreement that USCIS may release his or her records to you. Again, you may fulfill these requirements by completing **Item Numbers 1.a. - 4.i.** and having the individual complete **Item Numbers 8.a.** or **8.b.** 

If the Subject of Record is deceased, select **Item Number 8.c.** and attach appropriate proof of death, such as an obituary or a death certificate with your request.
