This request provides a 30-day comment period required by OIRA. The Coast Guard published the 60-day notice (84 FR 5458, February 21, 2019) required by 44 U.S.C. 3506(c)(2). That notice elicited no comments. Accordingly, no changes have been made to the Collections.

### Information Collection Request

*Title:* Boat Owner's Report, Possible Safety Defect.

*OMB Control Number:* 1625–0071.

*Summary:* The collection of information provides a means for consumers who believe their recreational boats or designated associated equipment contain substantial risk defects or fail to comply with Federal safety standards to report the deficiencies to the Coast Guard for investigation and possible remedy.

*Need:* Title 46 U.S.C. 4310 gives the Coast Guard the authority to require manufacturers of recreational boats and certain items of designated associated equipment to notify owners and remedy: (1) Defects that create a

substantial risk of personal injury to the public; and (2) failures to comply with applicable Federal safety standards.

*Forms:* CG–5578, Boat Owner's Report—Possible Safety Defect.

*Respondents:* Owners and users of recreational boats and items of designated associated equipment.

*Frequency:* One time.

*Hour Burden Estimate:* The estimated burden has decreased from 18 hours to 12 hours a year, due to a decrease in the estimated annual number of respondents.

*Authority:* The Paperwork Reduction Act of 1995; 44 U.S.C. Chapter 35, as amended.

Form I-589 is necessary to determine whether an alien applying for asylum and/or withholding of removal in the United States is classified as refugee, and is eligible to remain in the United States.

(5) *An estimate of the total number of respondents and the amount of time estimated for an average respondent to respond:* The estimated total number of respondents for the information collection I-589 is approximately 114,000 and the estimated hour burden per response is 12 hours per response; and the estimated number of respondents providing biometrics is 110,000 and the estimated hour burden per response is 1.17 hours.

(6) *An estimate of the total public burden (in hours) associated with the collection:* The total estimated annual hour burden associated with this collection is 1,496,700 hours.

(7) *An estimate of the total public burden (in cost) associated with the collection:* The estimated total annual cost burden associated with this collection of information is \$46,968,000.
