The Federal Assets Sale and Transfer Act ([Public Law 114-287](#)) (FASTA) was passed in December 2016 and requires the Office of Management and Budget and GSA to identify opportunities for the Federal Government to reduce its inventory of civilian real property - namely through accelerated sales of approved properties, more efficiently utilize existing properties, and reduce the cost for maintaining these properties.
