The information enhances the Coast Guard ability to respond to an emergency and minimize the environmental damage from an oil or hazardous material spill. The information is also use to monitor certain transfer operations. Form CG-4020 contains basic business contact information, which may include the name, address and phone/fax/email of the facility and/or vessel, if owned/operated by an individual. The authority for this collection is 33 U.S.C. 1225.</p> <p>DHS Privacy Office (PRIV) finds this is a privacy sensitive system. The collection of business contact information for the purpose of USCG response to environmental damage is covered by DHS/USCG/PIA-008. The retrieval of information is by vessel or facility-specific information, and no SORN coverage is required; however, DHS/USCG-013 SORN does provide general notice of this type of information collection. The Privacy Act Statement should be changed to a Privacy Notice due to information not being retrieved by a unique identifier. This PTA is valid until April 30, 2022.</p>
