

# **RFS2** Activity Report (**RFS010**#): Instructions for Completing

### Who must report

• All parties who own RINs during a reporting period (any calendar quarter), must submit the required RFS2 Activity report.

### **Reporting requirements**

- Complete this report representing all required elements calculated as a single entry for the compliance period.
- 40 CFR 80.1451(a) and (c) sets forth the additional reporting requirements (available at: <u>http://www.ecfr.gov/cgi-bin/text-</u> idx?SID=92f329a74300c94eb629af9882f2297a&mc=true&node=se40.19.80\_11451&rgn=div8)
- **Required fields and NA values** Certain report fields or parameters may be specific to select product types. If a report field does not apply to the reported batch, enter the value "NA". Do not leave the field blank.

### **Reporting deadlines**

• All RIN owning parties shall report on a quarterly basis:
