Overview

DoD is committed to protecting your privacy and the security of the information you entrust with us. We respect your privacy and have taken measures to provide appropriate levels of security to protect your personal information. Your use of MHS GENESIS Patient Portal is governed by the terms of this Policy, and by using or accessing MHS GENESIS Patient Portal you agree to be bound by it.

MHS GENESIS Privacy Act Statement

This statement serves to inform you of the purpose for collecting the personal information required by MHS GENESIS, and how it will be used.

AUTHORITY: 10 U.S.C. 8111, Sharing of Department of VA and DoD Healthcare Resources; 10 U.S.C. 1104, Sharing of Healthcare Resources with the Department of Veterans Affairs; 38 U.S.C. 8111, Sharing of Department Veterans Affairs and Department of Defense Health Care Resources; National Defense Authorization Act (NDAA) 2017, Defense Health Programs; 10 U.S.C. 136, Under Secretary of Defense for Personnel and Readiness; 10 U.S.C. Chapter 55, Medical and Dental Care; 42 U.S.C. Chapter 32, Third Party Liability for Hospital and Medical Care; 32 CFR Part 199, Civilian Health and Medical Program of the Uniformed Services (CHAMPUS); DoD Instruction 6025.18, Privacy of Individually Identifiable Health Information in DoD Health Care Programs; DoD Regulation 6025.18-R, DoD Health Information Privacy Regulation; DoD Instruction 6040.45, DoD Health Record Life Cycle Management; DoD Instruction 6015.23, Foreign Military Personnel Care and Uniform Business Offices in Military Treatment Facilities (MTFs); and E.O. 9397 (SSN), as amended.

PURPOSE: To collect information from you to provide and document your medical care; determine your eligibility for benefits and entitlements; adjudicate claims; determine whether a third party is responsible for the cost of Military Health System (MHS) provided healthcare and recover that cost; evaluate your fitness for duty and medical concerns which may have resulted from an occupational or environmental hazard; evaluate the MHS and its programs; and perform administrative tasks related to MHS operations and personnel readiness.

ROUTINE USES: Information in your records may be disclosed to: Private physicians and Federal agencies, including the Department of Veterans Affairs, Health and Human Services, and Homeland Security (with regard to members of the Coast Guard), in connection with your medical care; Government agencies to determine your eligibility for benefits and entitlements; Government and nongovernment third parties to recover the cost of MHS provided care; Public health authorities to document and review occupational and environmental exposure data; and Government and nongovernment organizations to perform DoD-approved research.

Information in your records may be used for other lawful reasons which may include teaching, compiling statistical data, and evaluating the care rendered. Use and disclosure of your records outside of DoD may also occur in accordance with 5 U.S.C. 552a(b) of the Privacy Act of 1974, as amended.

Any protected health information (PHI) in your records may be used and disclosed generally as permitted by the HIPAA Privacy Rule (45 CFR Parts 160 and 164), as implemented within DoD by DoD 6025.18-R. Permitted uses and disclosures of PHI include, but are not limited to, treatment, payment, and healthcare operations.

APPLICABLE SORN: The SORN applicable to this system is EDHA 07, Military Health Information System, until the completion and approval of the standalone MHS GENESIS SORN is completed.

Your Health Information in MHS GENESIS Patient Portal Data

The MHS GENESIS Patient Portal provides a view into your Electronic Health Record (EHR) and allows you and your Military Health System providers to communicate securely. The information available for you to view through the MHS GENESIS Patient Portal is not a comprehensive view of all the data in your EHR. When you send information to your healthcare provider through the MHS GENESIS Patient Portal, MHS clinical policies will determine if that information is stored in your EHR where it will be accessible to members of your care team and staff. Information that becomes a part of your EHR remains in your EHR even if you stop using MHS GENESIS Patient Portal. In accordance with MHS clinical policies, only secured messages that become part of your EHR will be viewable.

Messages sent through the MHS GENESIS Patient Portal may not be limited to your Military Health System provider. Your physician or other professional health care provider may designate other Military Health System personnel to manage and respond to your messages. These may include nursing or other administrative staff who review messages and either respond or route the message to a provider for response. You should consider this before using the MHS GENESIS Patient Portal messaging feature to communicate sensitive matters. You may prefer to discuss such matters directly with a specific Military Health System provider to better preserve your privacy.

To access the MHS GENESIS Patient Portal, patients will login using their DS LOGON Username and Password (https://myaccess.dmdc.osd.mil/). Access/authentication will be governed by DS LOGON.

Sharing Your Protected Health Information

Through the self-service portal, you may set up family member proxy access by granting viewing privileges to family members. The family member who is granted proxy access to your account will be able to view the same information through the MHS GENESIS Patient Portal as you are able to view. If you grant proxy access to another individual through the MHS GENESIS Patient Portal, you acknowledge and accept responsibility for your decision to provide them access to potentially sensitive information

How Information is Collected and Used

The MHS GENESIS Patient Portal collects certain information from you in three primary ways: (i) from web server logs, (ii) with cookies and web analytics tools, and (iii) user-supplied information.

- (i) IP Addresses (Server Log Information). An IP address is a number automatically assigned to your computer whenever you access the Internet. All computer identification on the Internet is conducted with IP addresses, which allow computers and servers to recognize and communicate with each other. The MHS GENESIS Patient Portal collects IP addresses in order to conduct system administration, report Aggregate Information (as defined below) to affiliates or partners, and to conduct web site analysis. The MHS GENESIS Patient Portal will also use IP addresses to identify any connecting devices and aid in the identification of users that do not comply with the Terms of Use agreement, or threaten the MHS GENESIS Patient Portal service, web site, users, clients or others.

Cookies are pieces of information that a website transfers to an individual's hard disk for record-keeping purposes. These cookies do not contain any personal information. Use of Cookies

Cookies may be categorized as session or persistent, which describes the length of time that they stay on your system. Persistent cookies are not used on MHS GENESIS Patient Portal. A session cookie is a small piece of textual information that a server places temporarily on your browser during the time your browser is open. Session cookies in the MHS GENESIS Patient Portal enable the recognition of your logon identification when you log on so your identity does not need to be established for every request.

How Information is Shared and Disclosed

DoD and its EHR Contractor does not rent, sell or share personal information about you with other people or nonaffiliated companies, except when we have your permission, or under the following circumstances:

- (a) Disclosures to Third Parties Assisting In Our Operations. Your personal information may be provided to affiliates, subsidiaries and trusted partners who work on behalf of or with us under confidentiality agreements. These companies may use your personal information to assist us in our operations.
- (b) Aggregate Information. Information about you that does not allow you to be identified or contacted ("Aggregate Information") may be provided to third parties, such as usage information and trends. When Aggregate Information is provided, it is pooled with many individual records and stripped of any data that could be used to identify you before it is used.
- (c) Disclosures Under Special Circumstances. Information about you may be provided to respond to subpoenas, court orders or legal process, or to establish or exercise our legal rights or defend against legal claims. We believe it is necessary to share information in order to investigate, prevent or take legal action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of the Terms of Use, or as otherwise required by law.

These restrictions on disclosure of information may include accessing personal health and medical information through electronic or Internet based services. Security
