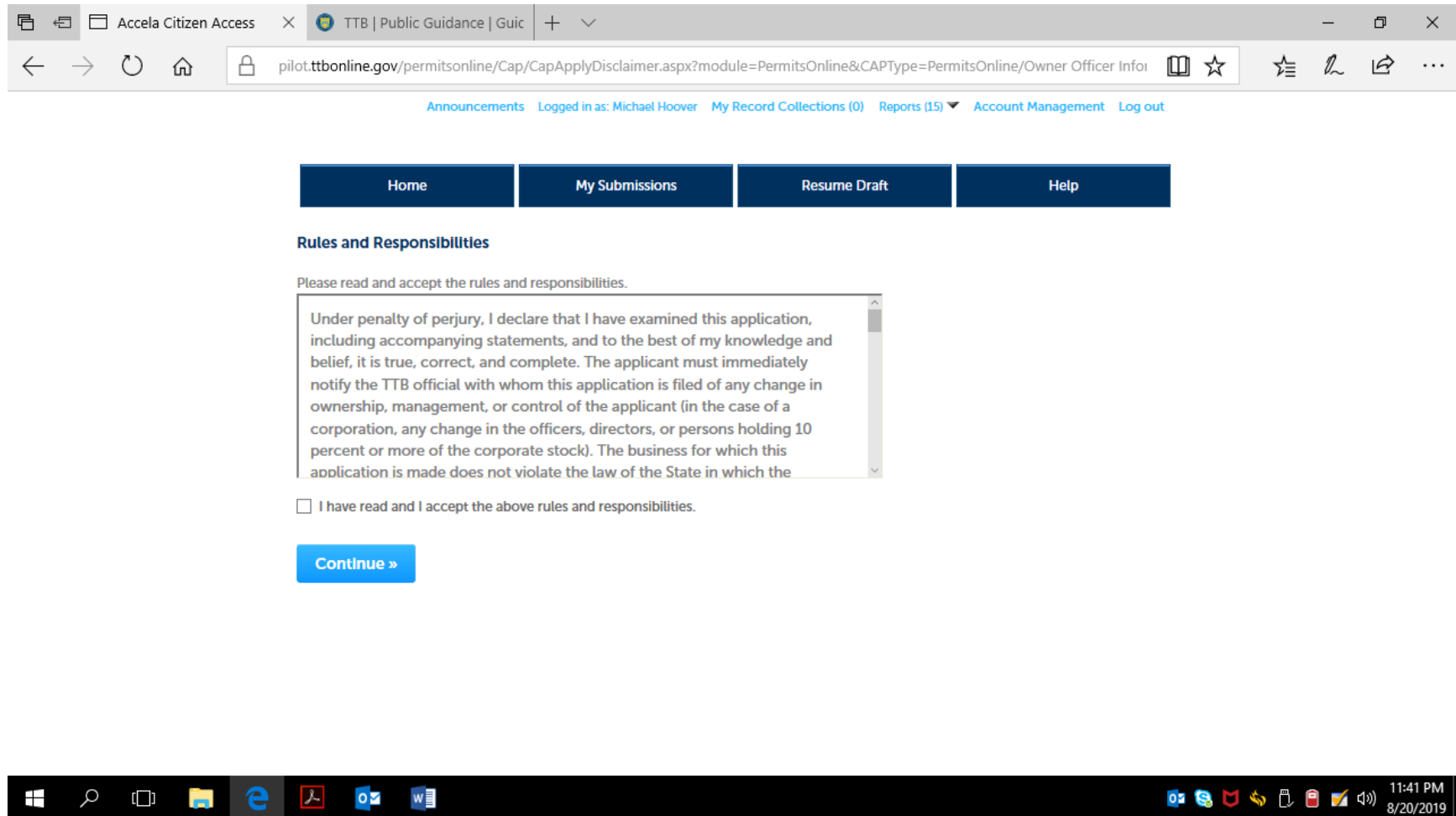

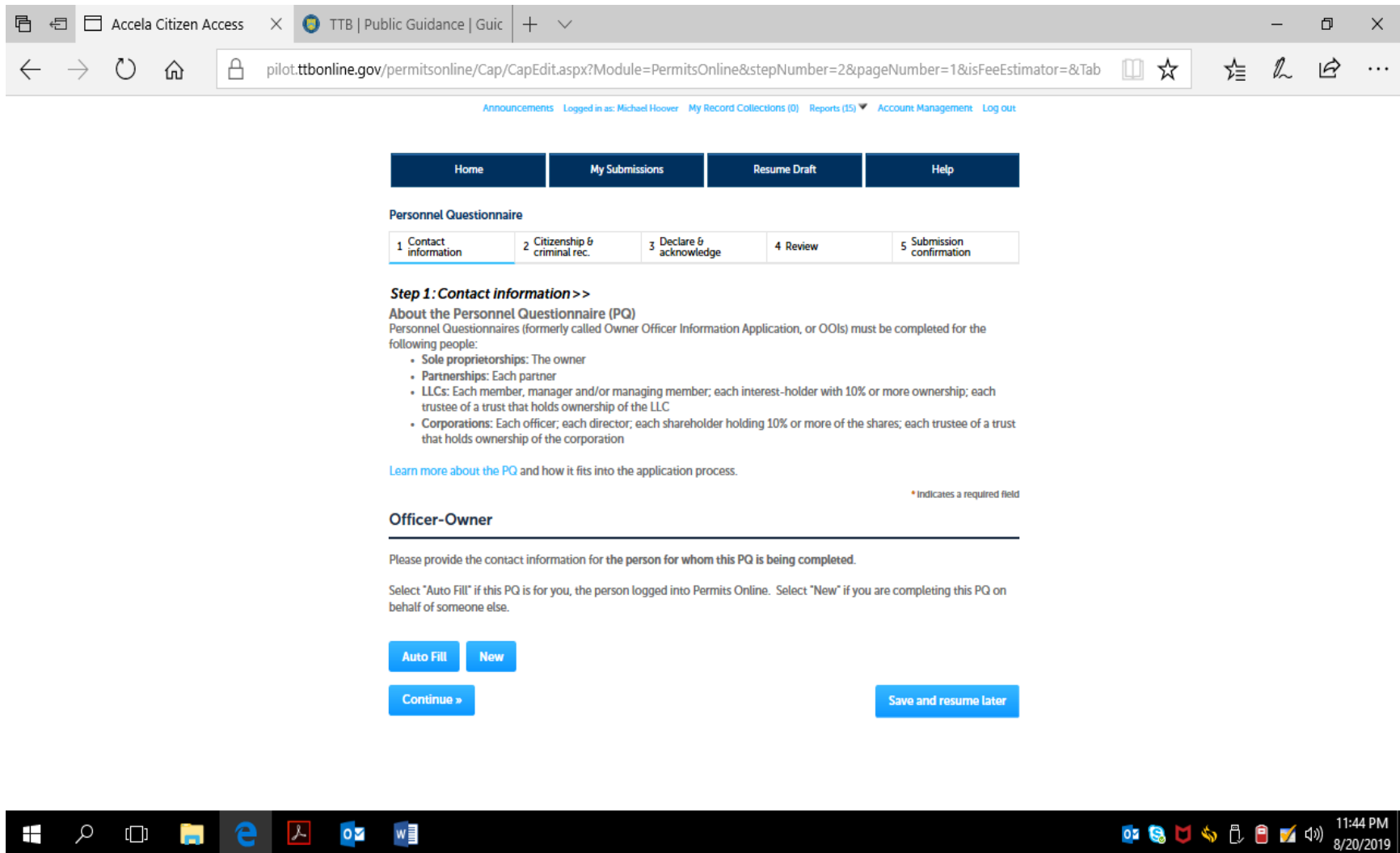

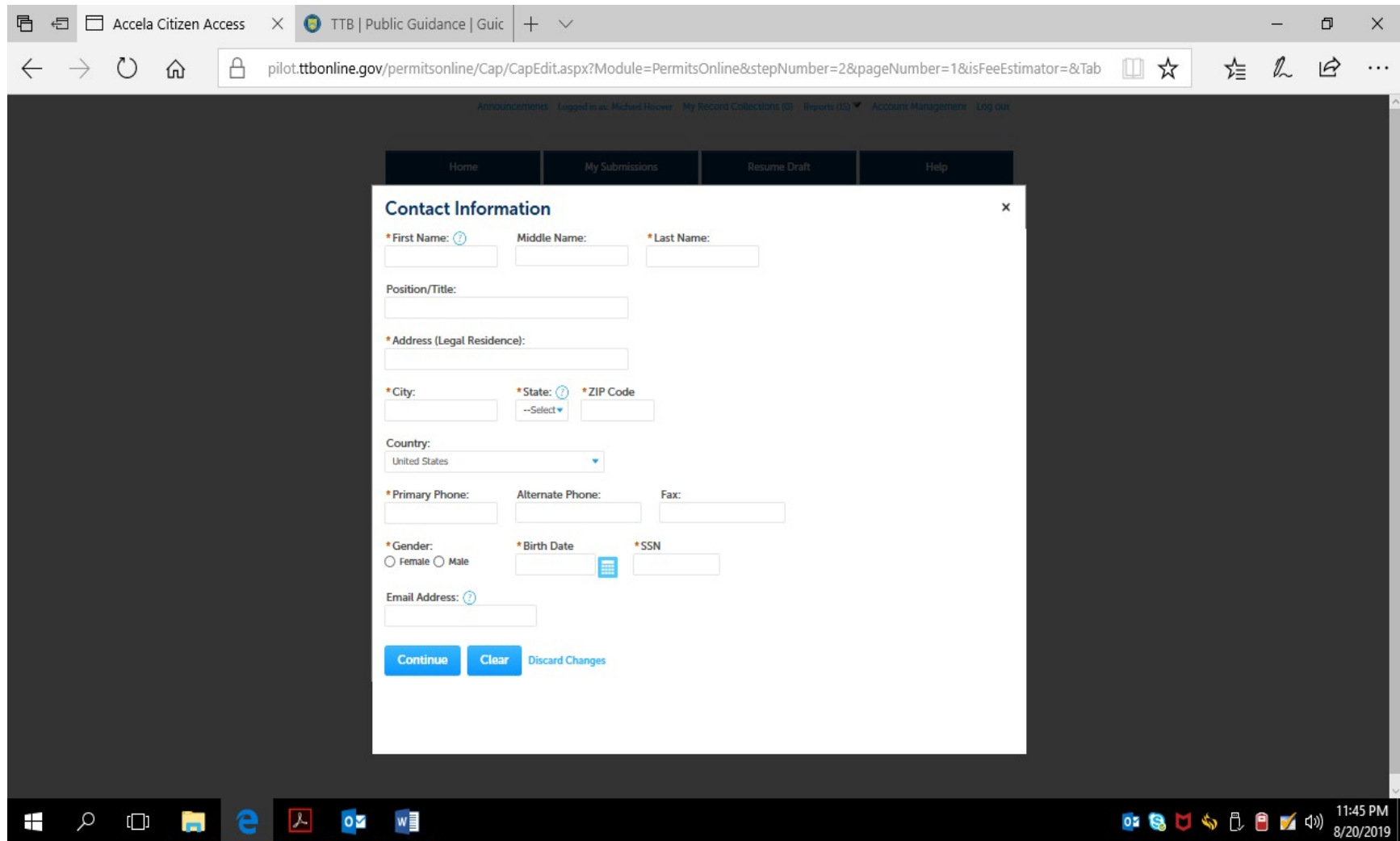
After clicking “Fill out a Personnel Questionnaire,” on the PONL log-in page, the respondent is presented with the Rules and Responsibilities screen:



After accepting the Rules and Responsibilities, the respondent is taken to Step 1 -- Contact Information:

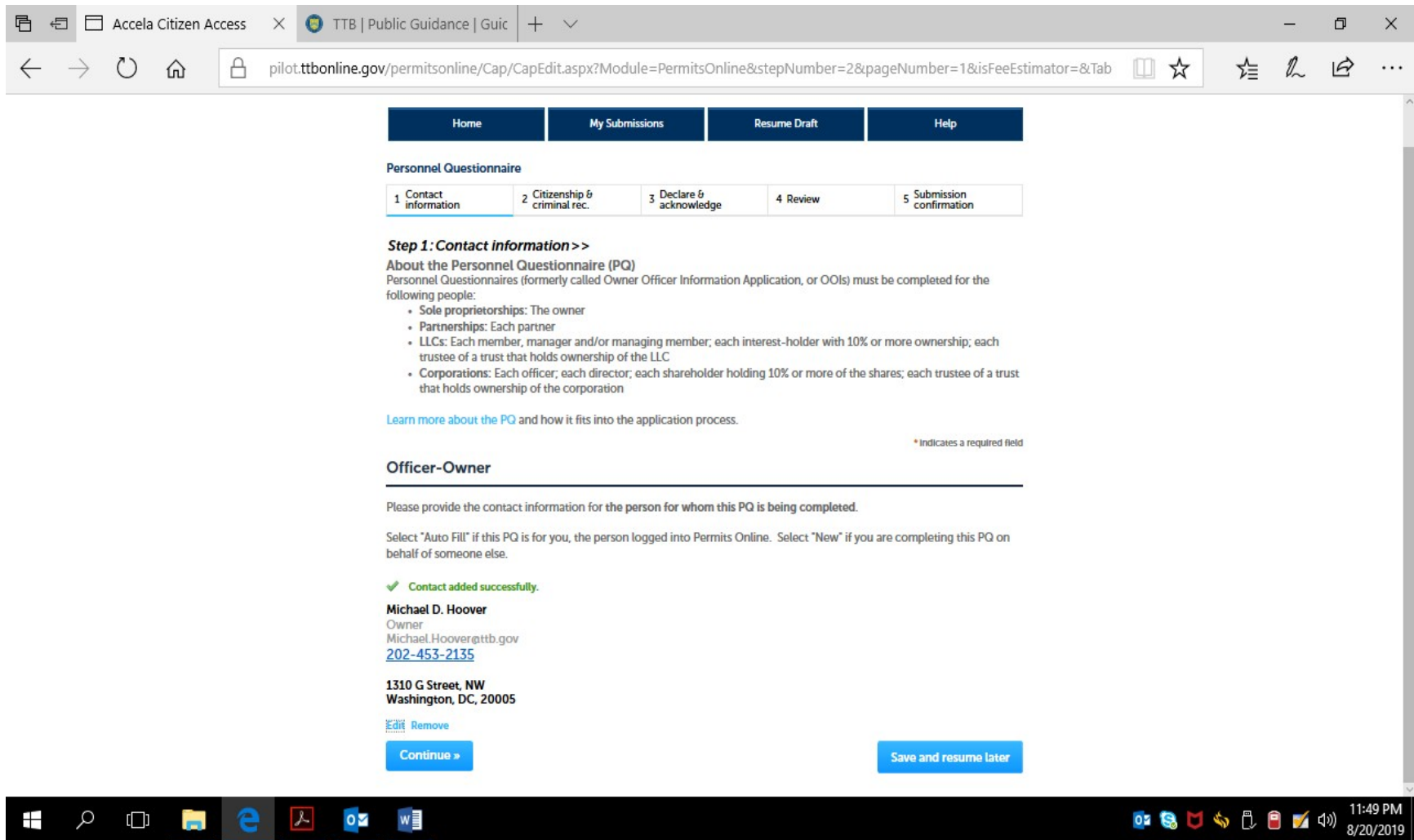


Clicking on “New” respondent results in the Contact Information page:

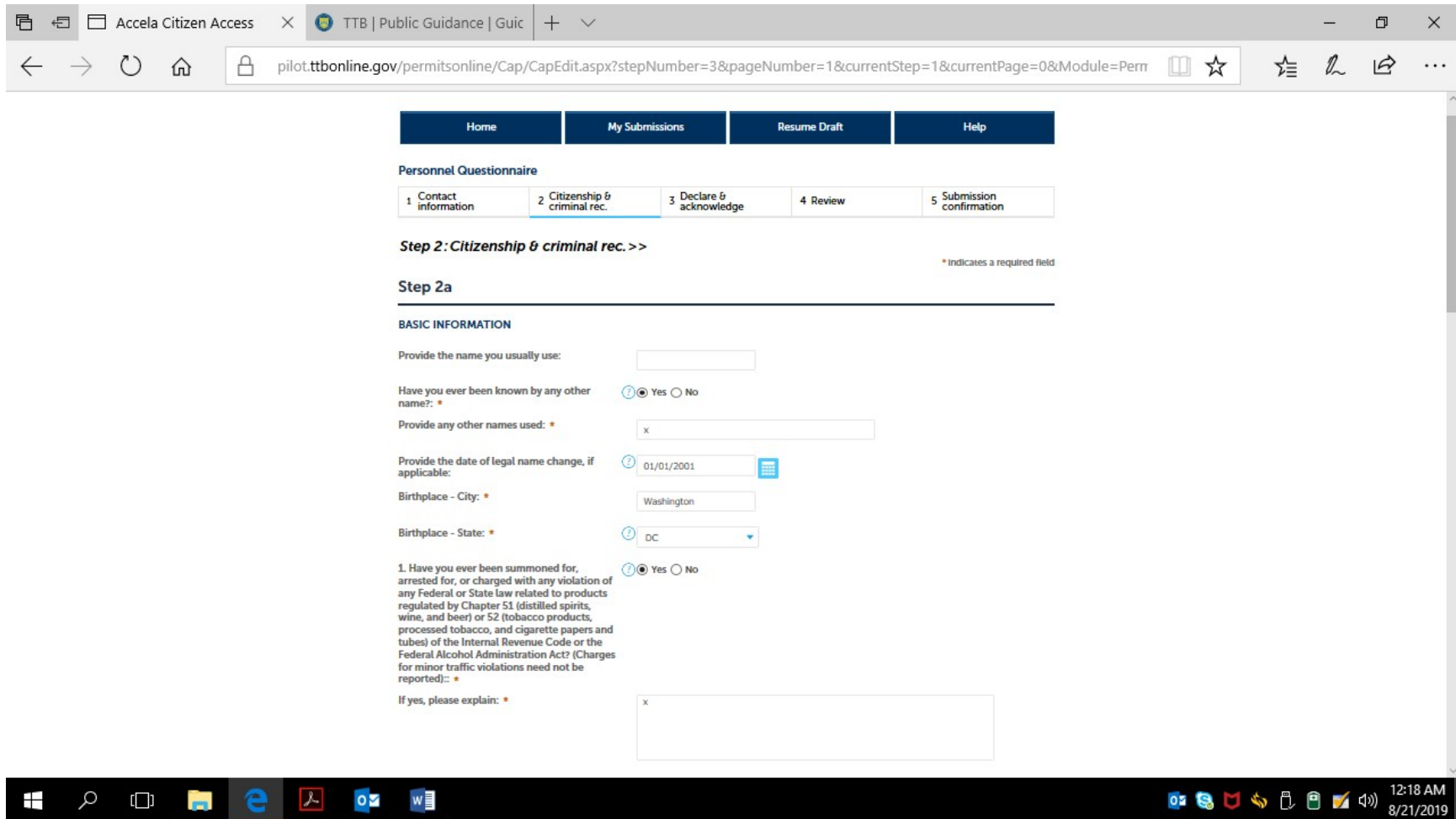
Completion of the Contact Information page results in a review page for that information:
