This application is being submitted for reinstatement without changes because there will be a grant competition in fiscal year (FY) 2020. The program is authorized under Title III, Part A, Section 320 (84.031L) of the Higher Education Act (HEA) of 1965, as amended. This program awards discretionary grants to eligible institutions of higher education so that they might increase their self-sufficiency by improving academic programs, institutional management, and fiscal stability.

This collection of information is gathered electronically by the Department for the purpose of obtaining programmatic and budgetary information needed to evaluate applications and to make funding decision based on the authorizing statute and the published selection criteria.

The application process is electronic. Applicants will submit their applications using the government-wide Grants.gov system. The applications will then transfer to the Department's G5 system. Program staff will use the G5 system to set up the panels for the competitive reading, and the peer reviewers will use G5 to read and score the applications.

Since the information submitted in this application is unique to each respondent and to the authorizing legislation, no duplication exists.
