LO L1	The model confidentiality agreement contained in this memorandum is made available by
2	the U.S. Office of Government Ethics to attorneys for their use in drafting proposed
13	confidentiality agreements in those cases where such an instrument is an appropriate component
L4 	of a qualified trust arrangement submitted for certification pursuant to section 102(f)(3) or (4)(B)
15	of the Ethics in Government Act of 1978 (Pub. L. 95-521, as amended) and subpart D of
16	5 C.F.R. Part 2634. Under the statutory scheme, a trust agreement is not permitted to be
17	recognized as creating an efficacious blind trust arrangement for any purpose under Federal law
18	unless it had been certified by the Office <u>prior</u> to its execution. Proposed confidentiality
9	agreement drafts submitted to the Office for consideration must adhere to the language of the
20	model except to the extent, as agreed to by the U.S. Office of Government Ethics, that variations
21	are required by the unusual circumstances of a particular case. The fiduciaries' certificates of
22	independence must be executed in the exact form indicated.
23	
24	It is strongly recommended in any case in which the use of a blind trust is contemplated
25	that the Office be consulted as early as possible. Prospective trustees or their representatives
26	should schedule an appointment with the staff of the U.S. Office of Government Ethics for an
27	orientation to the specialized procedures and requirements which have been established by law
28	with respect to blind trust administration prior to the certification of the trust. As a condition of
29	approval by the Office, prospective trustees must exhibit a familiarity with and commitment to
30	the specialized nature of blind trust administration.

5	child, and our representatives to restrict their communications in the manner described in this
6	paragraph.

Privacy Act Statement

Section 102(f) of the Ethics in Government Act of 1978 as amended (the "Ethics Act"), 5 U.S.C. Appendix, § 102(f), and subpart D of 5 C.F.R. part 2634 of the regulations of the U.S. Office of Government Ethics (OGE) require the reporting of this information for the administration of qualified trusts under the Act. - 2) To disclose information to any source when necessary to obtain information relevant to a conflict-of-interest investigation or determination.
- To disclose information to the National Archives and Records Administration or the General Services Administration in records management inspections conducted under authority of 44 U.S.C. 2904 and 2906.
- 4) To disclose information to the Office of Management and Budget at any stage in the legislative coordination and clearance process in connection with private relief legislation as set forth in OMB Circular No. A-19.
- 5) To disclose information when the disclosing agency determines that that the records are arguably relevant to a proceeding before a court, grand jury, or administrative or adjudicative body; or in a proceeding before an administrative or adjudicative body when the adjudicator determines the records to be relevant to the proceeding.
- 6) To disclose the public financial disclosure report and any accompanying documents to reviewing officials in a new office, department or agency when an employee transfers or is detailed from a covered position in one office, department or agency to a covered position in another office, department or agency.
- 7) To disclose information to a Member of Congress or a congressional office in response to an inquiry made on behalf of, and at the request of, an individual who is the subject of the record.
- 8) To disclose the information to contractors, grantees, experts, consultants, detailees, and other non-Government employees performing or working on a contract, service, or other assignment for the Federal Government, when necessary to accomplish an agency function related to this system of records.

- 9) To disclose information to appropriate agencies, entities, and persons when: (1) the agency maintaining the records suspects or has confirmed that there has been a breach of the system of records; (2) the agency maintaining the records has determined that as a result of the suspected or confirmed breach there is a risk of harm to individuals, the agency (including its information systems, programs, and operations), the Federal Government, or national security; and (3) the disclosure made to such agencies, entities, and persons is reasonably necessary to assist in connection with the agency's efforts to respond to the suspected or confirmed breach or to prevent, minimize, or remedy such harm.
- 10) To disclose information to another Federal agency or Federal entity, when the agency maintaining the record determines that information from this system of records is reasonably necessary to assist the recipient agency or entity in (1) responding to a suspected or confirmed breach or (2) preventing, minimizing, or remedying the risk of harm to individuals, the recipient agency or entity (including its information systems, programs, and operations), the Federal Government, or national security, resulting from a suspected or confirmed breach.
