A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

Pursuant to CFR 21.4260, the Department of Veterans Affairs (VA) is the approving authority for all postsecondary courses in foreign countries under the benefit programs administered by the VA.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

VA will use the information collected to determine if a program in a foreign country is approvable under CFR 21.4260. In order for a review and decision to be made, the VA needs supporting information from a foreign educational institution.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

Currently there is no means to collect the information electronically. The school will submit the information in a letter format to the VA requesting approval of a program. The letter may be mailed or emailed to the VA.

A review was conducted to identify any potential areas of duplication and none were discovered. There is no known Department or Agency that maintains this information, nor is it available from other sources within the VA.

The collection of information does not involve small businesses or entities.

Assurance of confidentiality is covered by 38 U.S.C. 5701 and the VA System of Records, <u>Compensation</u>, <u>Pension</u>, <u>Education and Vocational Rehabilitation and Employment Records – VA (58VA21/22/28)</u>, which are contained in the Privacy Act Issuances, 2012 Compilation.

a. Number of Respondents: 1014

a. Frequency of Response: Once [1014 X 20 / 60] = 338

b. Annual Burden Hours: 338

c. Estimated Completion Time: 20 minutes

d. The respondent population for the Submission of School Catalog to the State Approving Agency is composed of accredited educational institutions, with the exceptions of elementary and secondary schools. The VBA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics gathers information on full-time wage and salary workers. Accordingly, the median weekly earnings of full-time wage and salary worker is \$999.20. Assuming a forty (40) hour work week, the median hourly wage is \$24.98

Legally, respondents may not pay a person or business for assistance in completing the information collection and a person or business may not accept payment for assisting a respondent in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$8,443.24 (338 burden hours x \$24.98 per hour).

This submission does not involve any recordkeeping costs.
