Electronic Invoicing, and System Upgrade Improvements

Effective **September 16, 2019**, the WBSCM is upgraded to the most current SAP patch levels for all its core components. This upgrade also improves system conformance to [Section 508](#) accessibility guidelines. The last WBSCM system technical refresh occurred in July 2018. Review a [summary of changes](#) impacting users from the upgrade; also [review your IE settings](#) in the upgraded system to suppress a warning message when copying and pasting text within certain applications. Refer to the updated [WBSCM Portal Navigation Video Tutorial](#) and a new [WBSCM User Accessibility Guide](#).

After several rounds of successful pilots involving dozens of vendors, the new **electronic invoicing (eINV) process** is also now fully implemented for all domestic and international commodity vendors for new purchase orders. The [USDA Notice to Trade](#) provides additional details including vendor training in progress and relevant contact information.
