**Objective:** Objective A: Connect directly to Government Affairs (GA) Department, Public Affairs (PA) Department, or Human Resources (HR) Department

Objective B: Get contact information for GA, PA, or HR representative.

  6. How many trainees has your company hired since January 1, 2017? (*Open ended*)
  7. How many trainees does your company plan to hire over the next year? (*Open ended*)
  8. Would you or your senior leadership be interested in a follow up discussion with Department of Labor senior leadership around a future commitment to this training and how we can support you? (*Yes/No*)
