Airspace Waivers may be issued where the applicant can demonstrate safety mitigations through equipage that their UAS can safely operate in controlled airspace without seeking ATC authorization prior to each operation. Processing times for airspace waivers are significantly longer than processing times for airspace authorizations.

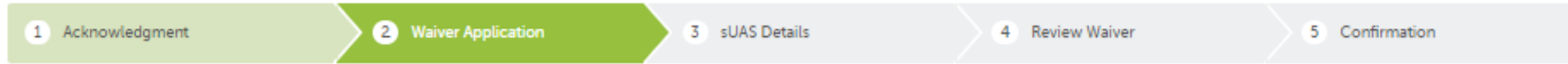

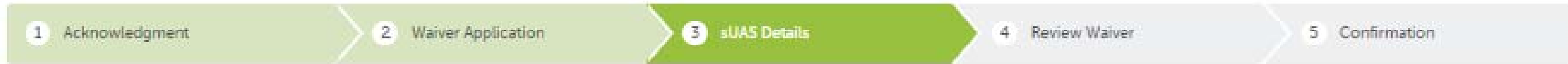

  - The cost of repair (including materials and labor) does not exceed \$500; or
