  approval to implement an electronic system to apply for and renew participation in

  the List, in addition to maintaining the paper version of the EOIR Form-56. Use

  of the electronic system is mandatory, and the paper collection should only be sued

  when the electronic system is unavailable. This is intended to elicit, in a uniform

manner, all of the required information for EOIR to determine whether an applicant meets the eligibility requirements for inclusion on the List.

5 An estimate of the total number of respondents and the amount of time estimated for an average respondent to respond: It is estimated that 107 respondents will complete

each form within approximately 30 minutes.
