

OMB CLEARANCE: SUMMARIZED DISCUSSION OF FORM REVISIONS

As discussed at the April 10<sup>th</sup> meeting with OCS, NASCSP and OCS will put forward only technical changes to Modules 1-4 of the CSBG Annual Report for inclusion in an OMB Clearance package. The projected approval date is January 15, 2020. This document outlines the proposed changes for each Module of the CSBG Annual Report for the upcoming OMB Clearance process.

PROPOSED CHANGES: GENERAL TECHNICAL CHANGES

The OMB Clearance should:

1. Include Numbering in forms submitted in the Clearance Package

- d. FNPI 5h: Correct typo by adding an “a” to the indicator.
