**PART I.—GENERAL INFORMATION**

**Background.**--This proceeding was instituted in response to a petition filed on June 27, 2017, by Nan Ya Plastics Corporation, America, Livingston, New Jersey. Antidumping duties may be assessed on the subject imports as a result of these proceedings if the Commission makes an affirmative determination of injury, threat, or material retardation, and if the U.S. Department of Commerce (“Commerce”) makes an affirmative determination of dumping. **Low melt polyester staple fiber** covered by these investigations is synthetic staple fibers, not carded or combed, specifically bi-component polyester fibers having a polyester fiber component that melts at a lower temperature than the other polyester fiber component (“low melt PSF”). The scope includes bi-component polyester staple fibers of any denier or cut length. The subject merchandise may be coated, usually with a finish or dye, or not coated.

The following merchandise is excluded from the scope: (1) polyester staple fiber equal to or greater than 3.3 decitex (greater than 3 denier, inclusive) that are not bi-component fiber, currently classifiable in the Harmonized Tariff Schedule of the United States at statistical reporting numbers 5503.20.0045 and 5503.20.0065; (2) polyester staple fiber of less than 3.3 decitex (less than 3 denier) that are not bi-component fiber, currently classifiable in the Harmonized Tariff Schedule of the United States at subheadings 5503.20.0025.

Low melt polyester staple fiber is classifiable under statistical reporting number 5503.20.0015 of the Harmonized Tariff Schedule of the United States (HTSUS). Although the HTSUS subheadings are provided for convenience and customs purposes, the written description of the merchandise under the order is dispositive.

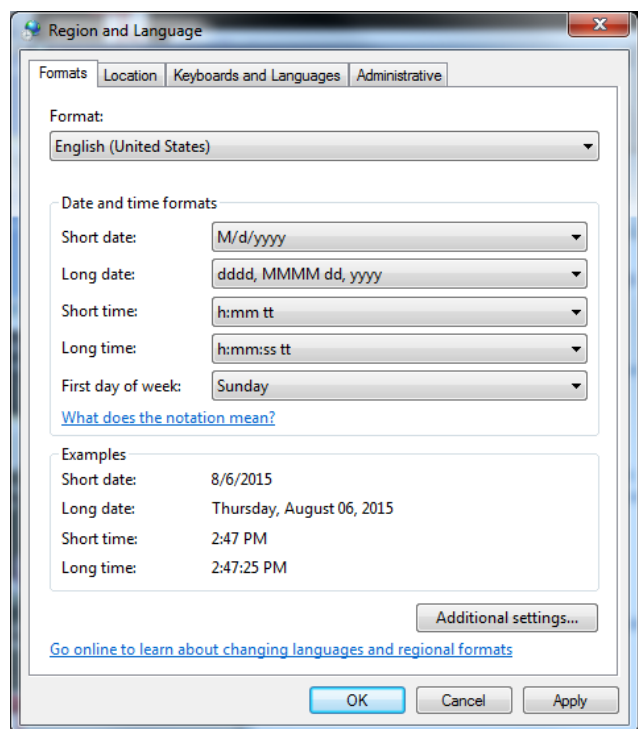
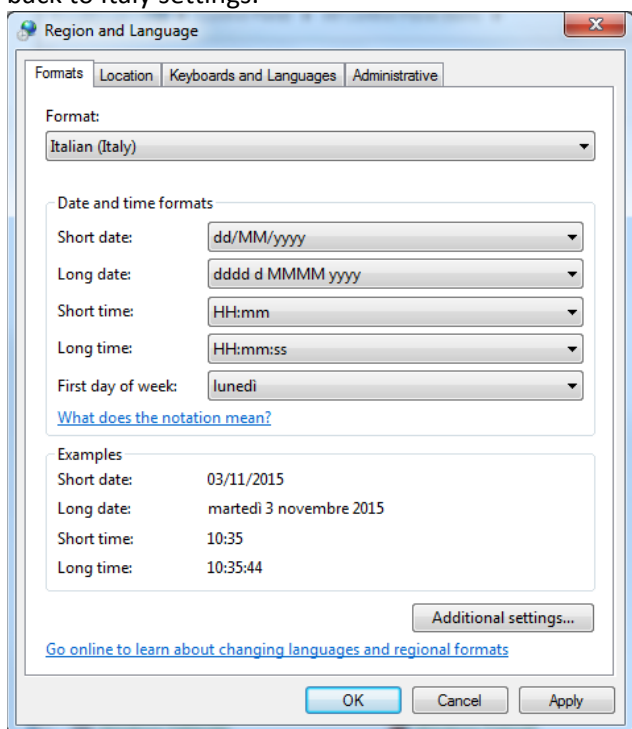
**Correcting Valid number error messages.**--If you are completing a Commission questionnaire in a country that uses periods (“.”) to delineate multiples of 1000 (e.g., one million would appear as \$1.000.000 instead of as \$1,000,000), you may be unable to enter in numbers greater than 999 in numeric form fields. This issues stem from your computer number formatting setting (e.g., not the MS Word document itself, but the computer from which you are opening up the document). In the United States commas (,) delineate multiples of 1000 and periods (.) delineate fractions less than one. Many EU countries use the reverse where multiples of 1000 are delineated with periods (.) and fractions less than one are delineated with commas (,). The US International Trade Commission’s questionnaires are set-up in the United States with the U.S. number formatting.
