## ABOUT THE STUDY

Assessing the Implementation and Cost of High Quality Early Care and Education (ECE-ICHQ) is a study of early care and education (ECE) centers. The purpose of this study is to produce tools that can point to activities and investments that are related to quality of early care and education.

### Why should my center participate?

You and your center are a valuable part of this study. We invite you to help us develop tools to understand what centers do to support quality ECE and what that costs. Taking part in ECE-ICHQ is voluntary. You may also decline to answer any questions we may ask.



To thank you, we will send your center a **\$500 gift card** for participating and staff will receive a **\$10 gift card** for completing a web survey.

### What will my center be asked to do?

If you agree to participate, we will collect information about your center using telephone interviews, a cost workbook, classroom observations, and a web-based survey. Center directors, staff familiar with the center's finances, and selected teaching staff will be invited to participate. We will also visit your center to observe up to three classrooms, and to help staff complete the web-based survey.

Our study team will schedule telephone interviews at times that are most convenient for you. And the web-based survey can be completed at any time.

### How was my center chosen?

Centers were chosen for variety in the numbers and ages of the children served and whether or not they serve children who receive subsidies, are part of Head Start, or rely solely on tuition paid by families.

### Who is conducting the project?

The Office of Planning, Research and Evaluation (OPRE) in the Administration for Children and Families (the government agency that oversees early care and education) is sponsoring the study. OPRE has contracted with Mathematica, a respected, non-partisan organization, to conduct this study.

## FREQUENTLY ASKED QUESTIONS ON ASSESSING THE IMPLEMENTATION AND COST OF HIGH QUALITY EARLY CARE AND EDUCATION (ECE-ICHQ)

---

➤ **Q: WHAT IS ECE-ICHQ ABOUT?**

The purpose of ECE-ICHQ is to produce measures of implementation and costs that can be used with existing observational measures of quality to find out what activities and investments can make a difference in improving ECE quality.

➤ **Q: WHO IS CONDUCTING THE PROJECT?**

The U.S. Department of Health and Human Services, Administration for Children and Families, Office of Planning, Research, and Evaluation (OPRE) sponsors the study. The study is being conducted by Mathematica, a respected, independent research organization whose studies of education and other programs have been used to inform national policymakers for more than 50 years.

➤ **Q: HOW WERE CENTERS CHOSEN FOR THE STUDY?**

Centers were chosen to reflect a range of characteristics, such as whether or not they serve children who receive subsidies for their care, or whether or not they offer a state prekindergarten program or are a part of Head Start program. Centers were also selected based on the number and ages of the children they serve. Participating centers will receive a \$500 gift card.

➤ **Q: WHAT WILL YOU ASK CENTER DIRECTORS TO DO?**

After a brief call to explain the study and answer any questions, we will ask center directors about their center's characteristics and staffing structure. In addition, we will ask directors to participate in telephone interviews to help us understand the center's activities and services.

➤ **Q: WHAT WILL YOU ASK STAFF WHO MANAGE FINANCES TO DO?**

After a brief call to explain the study and answer any questions, staff who are familiar with a center's finances will be asked to provide information about center costs including salaries, benefits, facilities, and overhead costs. They will be sent an electronic workbook to record this information and clear instructions for completing it.

➤ **Q: WHAT WILL YOU ASK CENTER STAFF TO DO?**

Center staff will be asked to complete a time-use survey online (or on paper if they prefer). It asks questions about how much time staff spend on various tasks, including teaching, working with families, staff development, communication activities, and management tasks. This should take approximately 15 minutes to complete. Each person who completes a survey will receive a \$10 gift card.

➤ **Q: WHAT DO THE SITE VISITS ENTAIL?**

A member of our study team will visit your center on up to three occasions. During our first visit, we will collect teacher and classroom information and invite staff to complete the time-use survey. During our subsequent visits, we will conduct observations of up to three classrooms in your center. We will observe each classroom(s) for about four hours to get an idea of classroom activities and children's interactions. We will provide a small gift to each classroom that we observe.

➤ **Q: HOW ARE CLASSROOMS CHOSEN FOR OBSERVATIONS?**

In selecting classrooms, we will consider the size of the center and the ages of children served in each classroom. Based on this information, we will randomly select up to three classrooms to observe.

➤ **Q: WHAT OTHER INFORMATION WILL YOU COLLECT ABOUT MY CENTER?**

To supplement the information we will gather from staff and from direct observations of classrooms, we may also obtain state administrative data (for example, QRIS data) about your center.

➤ **Q: WHY SHOULD I PARTICIPATE?**

You and your center are a valuable part of this study. Your input will help us develop tools to understand differences in what centers do to support quality ECE, and what that costs. It will also help us describe the costs associated with implementing quality care. Taking part in ECE-ICHQ is voluntary. You may also decline to answer any questions we may ask.

➤ **Q: WILL THE INFORMATION BE KEPT PRIVATE?**

The research team follows strict rules to protect privacy. All study staff are trained to protect privacy. The information in this study will be used only for research purposes and in ways that will not reveal who you are or identify your center. Federal or state laws may require us to show information to government officials (or sponsors) who are responsible for monitoring the safety of this study. Neither you or your center will be identified in any publication from this study.

➤ **Q: WHAT IS THE BACKGROUND OF THE STAFF WHO WILL BE VISITING MY CENTER?**

Mathematica hiring policy requires all newly hired and rehired field staff to pass a criminal background check. Sterling Testing Systems will conduct the background checks which will include a Social Security trace, criminal conviction search, sex offender search, and a department of motor vehicles report.
