E. CERTIFICATE OF OWNERSHIP FOR PERSONALLY OWNED WILDLIFE "Pet passport" (CITES)

Note: This form is used to request a passport-like certificate for a single animal (one pet per application).

- Your primary residence must be in the United States (i.e., residing the majority of the year in the United States) to be eligible for this certificate.
- Certificates cannot be re-issued if the pet is currently outside the United States; therefore the pet must return to the United States prior to the expiration of the certificate.
- Certificates issued are typically valid for three years, and are intended for multiple border crossings.
- Please review our webpage "Personal Pets" for important guidance and reminders.
- Per USDA requirement, birds may not enter the U.S. at a land border port from Mexico.

If you are interested in obtaining a single permit for multiple animals without needing multiple crossings, or are intending to move your pet overseas permanently, please use form 3-200-46.

Complete all questions on the application. Mark questions that are not applicable with "N/A". **If needed, use separate sheets of paper**. On all attachments or separate sheets you submit, indicate the application question number you are addressing. **A separate application and certificate is needed for each animal.**

- i. Scientific and common names of bird;
- ii. Hatch date, band/tag number or identifying markings, and sex of the animal;
- iii. Name and address of the facility where the animal was bred and born;
- iv. Location of parental stock; and
- v. A statement that the animal was bred at the above facility.
- vi. In addition, provide documentation demonstrating the history of transactions (e.g., chain or ownership of pet(s)).
- 11. If **you do not know the origin** of your pet, provide a signed and dated statement with a complete description of the circumstances under which you acquired the pet, including when, where, from whom, and any other pertinent information. Include pet store receipts or other information that would assist in determining the source of your pet.
- 12. For animals previously imported into the United States (i.e., did not originate from the United States), provide evidence that the animal was legally imported, including:
 - a. Copies of validated canceled CITES export permits or re-export certificates issued by the appropriate CITES office in the country from which the wildlife was imported, and a copy of the cleared Declaration for Importation (form 3-177).
 - b. If you did not make the original import, provide copies of the importer's documents outlined above and any invoice or other documents that show you purchased or otherwise obtained the wildlife from the original importer.
 - c. If you did not obtain the wildlife from the original importer, include documentation demonstrating the history of transactions.
 - d. For exotic birds previously imported, provide a copy of the Wild Bird Conservation Act (WBCA) import authorization.
- 13. If requesting a passport for a species listed on the **Migratory Bird Treaty Act** (listed in 50 CFR 10.13), provide Federal and/or State permit(s) or license numbers that authorize possession and acquisition
- 14. Transport conditions must comply with the CITES Guidelines for Transport of Live Animals or, in the case of air transport, with the International Air Transport Association (IATA) live animal regulations (contact airlines for additional information). Please provide a description of the shipping conditions including:
 - a. The type, size, and construction of any shipping container; and
 - b. The arrangements for watering or otherwise caring for your pet during transport.
- 15. When travelling with your pet, there may be animal health requirements specific for that destination. As soon as you know your travel details, contact your local veterinarian to assist with the pet travel process. Factors to consider may include meeting time frames for obtaining a health certificate, updating vaccinations, diagnostic testing, or administration of medications/ treatments. If you wish to use several different non-designated ports, you may be required to contact the Office of Law Enforcement for additional authorization.

Routine Uses: The collected information may be used to verify an applicant's eligibility for a permit to conduct activities with protected wildlife; to provide the public and the permittees with permit related information; to monitor activities under a permit; to analyze data and produce reports to monitor the use of protected wildlife; to assess the impact of permitted activities on the conservation and management of protected species and their habitats; and to evaluate the effectiveness of the permit programs. Disclosure: The information requested in this form is voluntary. However, submission of requested information is required to process applications for permits authorized under the listed authorities. Failure to provide the requested information may be sufficient cause for the U.S. Fish & Wildlife Service to deny the request.
