Summary of Changes from Previously Approved Collection The collection is new.

1. Need for the Information Collection

Washington Headquarters Services (WHS) needs to collect this information to be able to provide reasonable accommodations to WHS and WHS-serviced organizations' personnel needing mobility assistance for individuals with disabilities.

2. Use of the Information

A Pentagon-wide building-circular will be sent to inform all WHS and WHS-serviced organization employees of the registration process/Requirements. All individuals in need of Personal Mobility Devices (PMD), aka Scooters, will be required to register their vehicles.

Information will be collected from the Agencies that desire to provide PMDs for their personnel with mobility-related issues. The individual users of the PMD will be asked to complete the subject form by providing their identifying information (name, email address phone number etc.), along with their work location. In addition, they will provide the Make, Model and Serial number of the PMD they wish to register. The individuals will need a letter from their Agency or Company's Reasonable Accommodations Representative (RAR), verifying their need to use the PMD. Their Supervisor will verify their information. The Occupational Safety and Health Branch (OSHB) will collect and deposit the information collected during the process. Successful collection will result in an organized process for management of PMDs (Scooters) at the Pentagon Reservation.

3. <u>Use of Information Technology</u>

All (100%) potential users will be sent out this information via email, and they will be expected to return the completed document electronically, as well.

4. Non-duplication

The information obtained through this collection is unique and is not already available for use or adaptation from another cleared source.

5. Burden on Small Businesses

This information collection does not impose a significant economic impact on a substantial number of small businesses or entities.

6. <u>Less Frequent Collection</u>

This information will be collected once per the individual user, for the registration of the PMD. Once the individual leaves the Pentagon Reservation, that registration will be

discontinued and the PMD will be taken away. If the PMD is needed for another user, it will need to be registered again.
