**TITLE OF INFORMATION COLLECTION:** Tax Exempt and Government Entities

**PURPOSE:** This project is part of the ongoing effort to ensure the information architecture meets user needs. The initiative undertaken by OEOM Information Architecture and TEGE, specifically to understand and align architecture to the customers mental model for content organized within several Tax Exempt and Government Entities sections: Retirement Plans, Federal State & Local Governments, Tax Exempt Bonds and Indian Nation (Tribal) Governments.

Deliverables from this work will include analysis and recommendations report and draft sitemap.

The study will be conducted in two parts. Part one is an unmoderated online remote card sort survey with a minimum of 10 users per audience category. Part two is an unmoderated online remote Tree-jack survey with a minimum of 10 users per audience category.
