an exemption may be granted. The CTPB will issue, if deemed appropriate, a Certificate of Exemption letter stating that should your sales ever meet or exceed the 500 tree exemption threshold, you will be responsible for filing a sales report and sending payment of assessments in accordance with the Order (7 CFR 1214), by February 15<sup>th</sup> in the year following harvest.
