Such books and records must be made available during normal business hours for inspection by the CTPB. All information obtained from books, records, or reports will be kept confidential by the CTPB staff. Such information shall not be available to CTPB members, producers or importers.

Upon receipt of your Application for Exemption, the CTPB will make a determination whether an exemption may be granted. The CTPB will issue, if deemed appropriate, a Certificate of Exemption letter stating that should your sales ever meet or exceed the 500 tree exemption threshold, you will be responsible for filing a sales report and sending payment of assessments in accordance with the Order (7 CFR 1214), by February 15th in the year following harvest.
