Hi Alisha,

I'm writing to request a human subjects review and PRA determination for the attached proposal. I am requesting that this be review for a non-research determination as this activity is part of the public health response in these shelter settings. Additionally, shelter activities are likely starting as early as April 6, so an expeditious review would be wonderful.

In summary, several homeless shelters in the Atlanta metro area are engaging in systematic testing of the shelter population and we are proposing to capture some additional demographic and medical history information on those screened. We are also proposing to conduct follow-up symptom assessments and retrospective medical chart review on those found to be SARS-CoV-2 positive.

These activities may already fall under the larger epidemiologic investigation of novel coronavirus that CDC is conducting across the US, but because of the vulnerable population we wanted to run the protocol and forms by you before proceeding.
