- [pg. 5] Then select your payment types (the tool will present a screen for you to input dollar amounts).
- [pg. 6] Then you can review your information for any errors and file directly from IRS.gov
- [pg. 7] Here is the confirmation page.

- [pg. 11] The tool would show a summary of your filed 1099s

- e. Dedicated customer service support for issues and questions
- f. Notifications based on form status, due dates, and required actions
- g. Combined filing of federal and state information
- h. View, search, and filter previously submitted 1099 forms
- i. Autofill 1099 forms based on previously submitted form data
