

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

**Education Stabilization Fund-Elementary and Secondary Emergency Education Relief
Fund (ESSER) Recipient Data Collection Form**

1. Explain the circumstances that make the collection of information necessary. What is the purpose for this information collection? Identify any legal or administrative requirements that necessitate the collection. Include a citation that authorizes the collection of information. Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Aid, Relief, and Economic Security Act or the CARES Act.

This is a request for approval of an information collection that would collect information from State Educational Agencies (SEA) (and analogous grants to Outlying Areas) recipients regarding the use of funding authorized under section 18003 of the CARES Act, the Elementary and Secondary Emergency Relief Fund (ESSER) Fund. The ESSER Fund awards grants to SEAs and for the purpose of providing local educational agencies (LEAs), including charter schools that are LEAs, as well as Outlying Areas, with emergency relief funds to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the nation. LEAs must provide equitable services to students and teachers in non-public schools as required under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act).

This information collection is authorized under (Authority: [20 U.S.C. 1221e-3](#), [1231a](#), and [3474](#)) [[72 FR 3702](#), Jan. 25, 2007, as amended at [79 FR 76094](#), Dec. 19, 2014]

The information will be reviewed by U.S. Department of Education (Department) employees to ensure that ESSER funds are used in accordance with section 18003(d) of the CARES Act, and

will be shared with the public to promote transparency regarding the allocation and uses of funds.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision of adopting this means of collection. Data collection will be conducted through a Department-provided web portal. Electronic data collection through a web portal was chosen because of its efficiency, cost, and ability to pre-populate certain fields and conduct verification checks on others.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

This is a unique collection that responds to reporting requirements in the CARES Act; there are no other data collections that seek this information.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden. The collection does not impact small businesses or other small entities.

If this collection is not allowed to proceed, the Department will not be able to collect information to inform monitoring oversight and public transparency regarding the uses of funds under ESSER.

No such circumstances exist.

To comply with the Paperwork Reduction Act, the Department published a 60-day Federal Register notice for public comment. The Department received 16 comments; one of the 16 comments pertained to the Higher Education Emergency Relief fund. The remaining 15 comments were substantive and addressed in the attached Response Summary. The Department will issue a 30-day comment period notice and will respond to comments received as a result of that notice.

No payments or gifts will be provided to respondents.

The ESSER instrument is targeted to a total of 52 SEAs, 4 Outlying Areas, and 14,600 LEAs. The response burden is shown in Table 1. The burden estimates are based on discussions with experts in the Office of Elementary and Secondary Education in the Department.

There are no capital startup costs. The information collection will not create costs associated with generating, maintaining, and disclosing or providing the information that is not already identified in question 12 of this supporting statement.

The Department estimates the following: GS-13, 8 hours, 56 States and Outlying Areas = 448 hours X 45.42 per hour=\$20,348.16.

The initial increase resulted from a program change due to the enactment of a new statute, the CARES Act. The total new burden is estimated to be 73,560 burden hours and a cost of \$3,429,367.

SEAs will be asked to respond to the information collection in FY2021 Quarter 2.
