SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT SUBMISSION

Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Aid, Relief, and Economic Security Act or the CARES Act.

Section 18004(a)(3) of the CARES Act authorizes the Secretary to allocate funds for part B of Title VII of the Higher Education Act of 1965, as amended, for institutions of higher education that the Secretary determines have the greatest unmet needs related to coronavirus. This collection includes a budget and expenditure reporting form for institutions potentially eligible for funds under this section.

This information will be used to determine allocations under section 18004(a)(3) for eligible institutions of higher education.

Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

Due to the minimal burden required to complete this collection, the Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not allowed to proceed, the Department will not be able to fulfill the mandates of the CARES Act, and institutions and their students will not be able to receive the financial assistance authorized under this law.
