

## **Registration and Advanced Notice Instruction**

No person shall import a controlled substance listed in Schedule I or II or any narcotic controlled substance in Schedule III, IV or V unless and until such person is properly registered under the Act and the Administrator has issued an import permit to do so. See 21 CFR § 1312.11 (a)


A Registrant must furnish an application for an import permit (DEA Form 357) to the Import/Export Unit, Drug Enforcement Administration, prior to the importation. See 21 CFR § 1312.12 (a)


