




Application to Extend/Change Nonimmigrant Status



Currently, you may file an Application to Extend/Change Nonimmigrant Status (I-539) online if you are filing for yourself and wish to extend your nonimmigrant status except A, C, D, G, Q, T, U, or V nonimmigrant statuses, or if you work for NATO.

If you are filing with additional applicants or need to change or reinstate your non immigrant status, you must file a paper Form I-539.



At this time, you cannot file online if you:

- Need to extend your status and your nonimmigrant status is not listed above.
- Want to reinstate or change your nonimmigrant status, or
- Have additional applicants.

You will need to file a paper Form I-539.
