

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Aid, Relief, and Economic Security Act or the CARES Act.

Section 18004(a)(3) of the CARES Act authorizes the Secretary to allocate funds for part B of Title VII of the Higher Education Act of 1965, as amended, for institutions of higher education that the Secretary determines have the greatest unmet needs related to coronavirus. This collection includes application materials that will be used by institutions competing for discretionary grant funding under this section.

This information will be used to select recipients of discretionary grant funding under section 18004(a)(3).

Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

The Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not allowed to proceed, the Department will not be able to fulfill the mandates of the CARES Act, and institutions will not be able to receive the financial assistance authorized under this law.

This information collection does not require any special circumstances.

We estimate that it will take 250 respondents 18,750 total hours to complete and submit the required forms. The application includes one absolute priority, three competitive priorities and three selection criteria that have three or more factors that applicants must address as such we have included five hours for each priority and each selection criterion and five hours for standard forms and budget narrative. The 250 respondents are the estimated number of institutions of higher education that we expect will apply for additional funding under this CARES program. This estimate is based on a portion of the schools that was eligible for the various CARES funding that may continue to have unmet need. Additionally, since we expect to make such few awards, prior competitions' history had shown that when limited number of awards to be made there is a decrease in applications received.

- The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component.
